CHANGES TO THE RFQP:

ITEM NO. 1:

Revise section IX. REQUIRED SUBMITTAL FORMAT, G. FEES of the RFQP as follows:

G. Fees

1. Provide a detailed current fee schedule for the types of services offered.
2. ~~Include~~ **Provide** information about billing practices (i.e. lump sum, other), including reimbursable cost categories & hourly billing rates by position for additional services.
3. **Provide a table of hourly rates for each classification.**
4. **Provide a sample cost breakdown of hours for a \$6M new construction project with a 12-month duration utilizing the design-bid-build delivery method.**

QUESTIONS/REQUESTS FOR INFORMATION:

RFI NO. 1: For the requirement to provide all K–12 projects completed in the past five years, since we are an international firm, please confirm that providing our Southern California experience providing similar services would satisfy the requirement?

Answer

Respondents may provide similar public works experience in Southern California. K-14 work is preferred.

RFI NO. 2: Can the District confirm whether K–14 projects (including community colleges) are acceptable to include as part of the firm’s relevant experience?

Answer

K-14 projects are acceptable as relevant experience.

RFI NO. 3: Does the District currently utilize a third party software such as, LCPtracker or similar?

Answer

The District does not currently use any third party software for Labor Compliance.

RFI NO. 4: Please confirm that respondents can submit hourly rates based on our proposed classification to fulfill this requirement?

Answer
