DRAFT AUTHORIZATION

RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

In consideration for being permitted to utilize the facilities, services, and programs of the Bentonville Community Center, including the Downtown Activity Center (DAC) and the Melvin Ford Aquatic Center for any purpose, including, but not limited to, observation or use of the facilities or equipment, participation in any program affiliated with the Bentonville Community Center, Downtown Activity Center (DAC) and the Melvin Ford Aquatic Center, the undersigned, for himself or herself, any personal representatives, heirs, and next of kin, hereby acknowledges, agrees and represents that he or she has, or immediately upon entering or participating will inspect and carefully consider such premises and facilities or the affiliated program. It is further warranted that such entry into the Bentonville Community Center, Downtown Activity Center (DAC) and the Melvin Ford Aquatic Center for observation or use of any facilities, equipment, or participation in such program constitutes an acknowledgment that such premises and all facilities and equipment therein and such affiliated programs have been inspected and carefully considered and that the undersigned finds and accepts same as being safe, reasonably suited for the purpose of such observation, use or participation.

In further consideration of being permitted to enter the Bentonville Community Center, Downtown Activity Center (DAC), or the Melvin Ford Aquatic Center for any purpose, including, but not limited to, observation or use of facilities or equipment or participation in any program affiliated with the said facilities, the undersigned on their own behalf and on behalf of their family of guests and, if undersigned on their own behalf and on behalf of their family and guests, if undersigned is a parent or guardian, on behalf of their children or wards hereby agrees to the following:

The undersigned hereby releases, waives, discharges and covenants not to sue the City of Bentonville, its directors, officers, employees, and agents from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by negligence of the releases or otherwise while the undersigned is in, upon, or about the premises or any facilities or equipment therein, or participation in any program affiliated with the City of Bentonville.
