RE: Board of Directors Election for 2026-2027

The Karnes County Appraisal District is governed by a Board of Directors. Five Directors are appointed by the taxing units that participate in the district. If the County Assessor-Collector is not appointed to the board, the County Assessor-Collector serves as a nonvoting director as per Section 6.03(a) of the Texas Property Tax Code. Section 6.03(g) of the Texas Property Tax Code requires each taxing unit that is entitled to vote may **nominate by resolution** adopted by its governing body one candidate for each position to be filled on the Board of Directors. The presiding officer of the governing body of the unit shall submit the names of the unit's nominees to the Chief Appraiser **before October 15, 2025**.

Section 6.03(j) states before October 30, 2025, the Chief Appraiser shall prepare a ballot, listing the candidates whose names were timely submitted under Subsection (g) alphabetically according to the first letter in each candidate's surname and shall deliver a copy of the ballot to the presiding officer of the governing body of each taxing unit that is entitled to vote.

Please have the resolution for your nominee filed with the Appraisal District before October 15, 2025. Nominees will not be considered without a resolution.

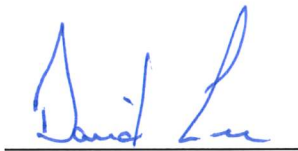
