

**ORDER CANVASSING RETURNS AND
DECLARING THE RESULTS OF SCHOOL BOARD TRUSTEE ELECTION**

WHEREAS, the Board of Trustees (“Board”) of the Clear Creek Independent School District (“District”) called an election (the “Election”) on May 2, 2026, for school board trustees for Single-Member District 2, and Single-Member District 3;

WHEREAS, the Board has reviewed and investigated all matters pertaining to these elections, including the order calling the election, relevant notices, appointed election officers, procedures related to holding the election and applicable election reports;

WHEREAS, the Board hereby canvasses the returns of the election, at which there was submitted to all resident, qualified electors of Single-Member District 2, for their vote, the following candidates:

WHEREAS, the Board has diligently inquired into the poll lists and the official elections returns, which were duly and lawfully made to the Board by the judges and clerks holding and conducting such elections, the poll lists and the official election returns showing separately the votes cast in the election;

WHEREAS, from these returns, the Board hereby finds that the following votes were cast in the election by voters who were resident, qualified voters in Single-Member District 2:

WHEREAS, the Board hereby canvasses the returns of the election, at which there was submitted to all resident, qualified electors of the District for their vote, the following candidates for Single-Member District 3:

WHEREAS, the Board has diligently inquired into the poll lists and the official elections returns, which were duly and lawfully made to the Board by the judges and clerks holding and conducting such elections, the poll lists and the official election returns showing separately the votes cast in the election;

WHEREAS, from these returns, the Board hereby finds that the following votes were cast in the election by voters who were resident, qualified voters in the District for Single-Member District 3:

NOW, THEREFORE, it is accordingly found, declared, and resolved by the Board of Trustees of Clear Creek Independent School District that:

Section 1. The Board officially finds, determines, and declares that the election was duly and properly conducted, that proper legal notice of such election was duly given in the English, Spanish, Chinese and Vietnamese languages (to the extent required by law), that proper election officers were duly appointed prior to the election, that the election was duly and legally held, that all resident, qualified voters of Single-Member District 2 and Single-Member District 3 were permitted to vote at the election, that due returns of the results of the election had been made and delivered, and that the Board has duly canvassed such returns, all in accordance with the laws of the State of Texas and of the United States of America, and the order calling the election.

Section 2. A plurality of the resident, qualified voters of the Clear Creek Independent School District voted in the election for Single-Member District 2 candidate Jamieson Mackay and Jamieson Mackay is hereby elected to such position.

Section 3. A plurality of the resident, qualified voters of the Clear Creek Independent School District voted in the election for Single-Member District 3 candidate and Arturo Sanchez is hereby elected to such position.


Section 4. The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this Resolution for all purposes and are adopted as a part of the judgment and findings of the Board.

Section 5. It is officially found, determined, and declared that the meeting at which this Order is adopted was open to the public and public notice of the time, place and subject matter of the public business to be considered at such meeting, including this Order, was given, all as required by Chapter 551, as amended, Texas Government Code.

Section 6. The President or Vice President of the Board of Trustees is authorized to execute and a second member of the Board of Trustees is authorized to attest and seal this Order on behalf of the Board of Trustees.

Section 7. This Order is effective immediately upon its passage and approval.
