Having a deadline helps the district plan for teachers, class sizes, and student services for the upcoming school year. Submitting requests on time helps us prepare schools to best serve all students.

All transfer request forms must be completed and turned in to the Central Office no later than June 12, 2026. Requests received after the deadline may only be considered if space is available.

Please remember that submitting a transfer request does not guarantee approval. All requests will be reviewed using district protocols and available space at each school.
