

ORDINANCE NO. 2026-07

**AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF THE BOROUGH OF
AUDUBON, COUNTY OF CAMDEN AND STATE OF NEW JERSEY AMENDING
CHAPTER 62, TRAFFIC AND VEHICLES, ARTICLE II, STOPPING, STANDING AND
PARKING, DIVISION 1, GENERALLY, SECTION 62-45, PARKING TIME LIMITED,
IN THE CODE OF THE BOROUGH OF AUDUBON**

WHEREAS, the Board of Commissioners of the Borough of Audubon find it necessary to amend the Code of the Borough of Audubon regarding signs throughout the Borough of Audubon; and

WHEREAS, municipalities are permitted to designate parking restrictions on roads and right of ways throughout the municipality; and

NOW THEREFORE, BE IT ORDAINED by the Board of Commissioners of the Borough of Audubon, County of Camden, and State of New Jersey, as follows:

SECTION 1: Article II of Chapter 62 of the Borough of Audubon Code is hereby amended to read as follows:

Sec. 62-45. – Parking time limited.

No person shall park a vehicle for longer than the time limited between the hours listed on any day upon any of the streets or parts of streets described.


