

Walker Park Elementary Pre-K through 5th grade Before & After School Program 2026 - 2027 Registration

Thank you for your interest in our programs for the 2026 - 2027 school year.

Before School Program Information- Hours 6:30 am - 8:00 am

Start date: Monday, August 3rd for students that have **preregistered**.

Location: For the Before School Program students will enter at the main entrance. Parents must walk students to the door. Students will not be allowed to enter the building before 6:30 a.m.

After School Program Information-Hours 3:25-6:00 pm

Start date: Monday, August 3rd for students that have **preregistered**.

Check-in/out Procedures: At 3:25 pm all after school students are dismissed to the After School Room and counted present for the day. Parents should report to the front office to check out students from the program. Please make sure you have a photo ID available to pick up your child.

Late fees: Late fees will apply if your child is not signed out by 6 pm (Staff's clock out time). The charge is \$10 for 1-10 minutes late and then \$1 per minute until the child is picked up. Late payment is due upon pick up. Please call the school at 770-207-3240 if you are running late. If a student is picked up late 3 times he/she may be dismissed from the program.

Homework: help will be available Monday, Tuesday, and Thursday until 4:45. It is the responsibility of the student to bring their books and materials for homework and to report to the homework station.

Students with limitations: Our before and after school enrichment programs are staffed and planned for students who can independently transition between centers with a ratio of 1 staff:25 students.

WPES Before & After School Rules and Consequences

Rules:

- Stay with your group at all times.
- Follow directions the first time they are given.
- Be respectful of adults and your peers.
- Use appropriate language.
- Keep your hands and feet to yourself.
- Only approved websites may be accessed.

Consequences:

- Verbal warning
- Time out with teacher
- Time out with director- parent will be notified
- If a student receives 3 referrals to director he/she may be dismissed from the program at the director/and or administrator's discretion

2026 - 2027 FEES

\$25.00 Registration Fee for every family. Registration fees are due with completed application one day BEFORE your child may attend either program. This fee pays for supplies and snacks for our program throughout the year. **Registration fee plus first week's fees will be due by open house along with a signed application for students to attend. Staff members in Walton County Schools will receive a 50% discount.**

BEFORE SCHOOL ONLY- \$6.00 per day/per child

DROP IN AFTER SCHOOL ONLY- \$15.00 per day/per child

FULL TIME (5 DAYS/WEEK) AFTER SCHOOL ONLY	
1 child	\$50.00
2 children	\$85.00
3 or more children	\$125.00

FULL TIME (5 DAYS/WEEK) BEFORE & AFTER SCHOOL	
1 child	\$75.00
2 children	\$125.00
3 or more children	\$150.00

** After care rates are discounted if you stay each day the entire week, otherwise it is \$15 a day.**

My Payments Plus: My Payments Plus is the county's preferred method of payment for activities. Registration fees and weekly payments may be made online through My Payments Plus. My Payments Plus may be accessed through the Parent Portal on the main website - the same as a lunch account may be accessed and paid. The registration cost is \$25 for a family and indicated as such on My Payments Plus. Parents will need the student's ID number to set up or access an account. The website for registration and payment online is www.mypaymentsplus.com. You will need to pay your registration fee online, as well as complete the Before/After School application and turn it in before your child may attend either program. Please make payments at the beginning of each week. Payment is due in advance of services to be received.

Late Payments: If payment is not received by Friday, a \$5 late fee will be added to the balance and the overdue balance plus the next week's payment will be due in order to attend the next week. Parents who wish to pay every other week must still pay in advance. This means two weeks of fees would be due at the beginning of the first week. If payments are received late 3 times during the school year, your child may be dismissed from the program.
