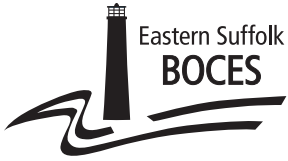

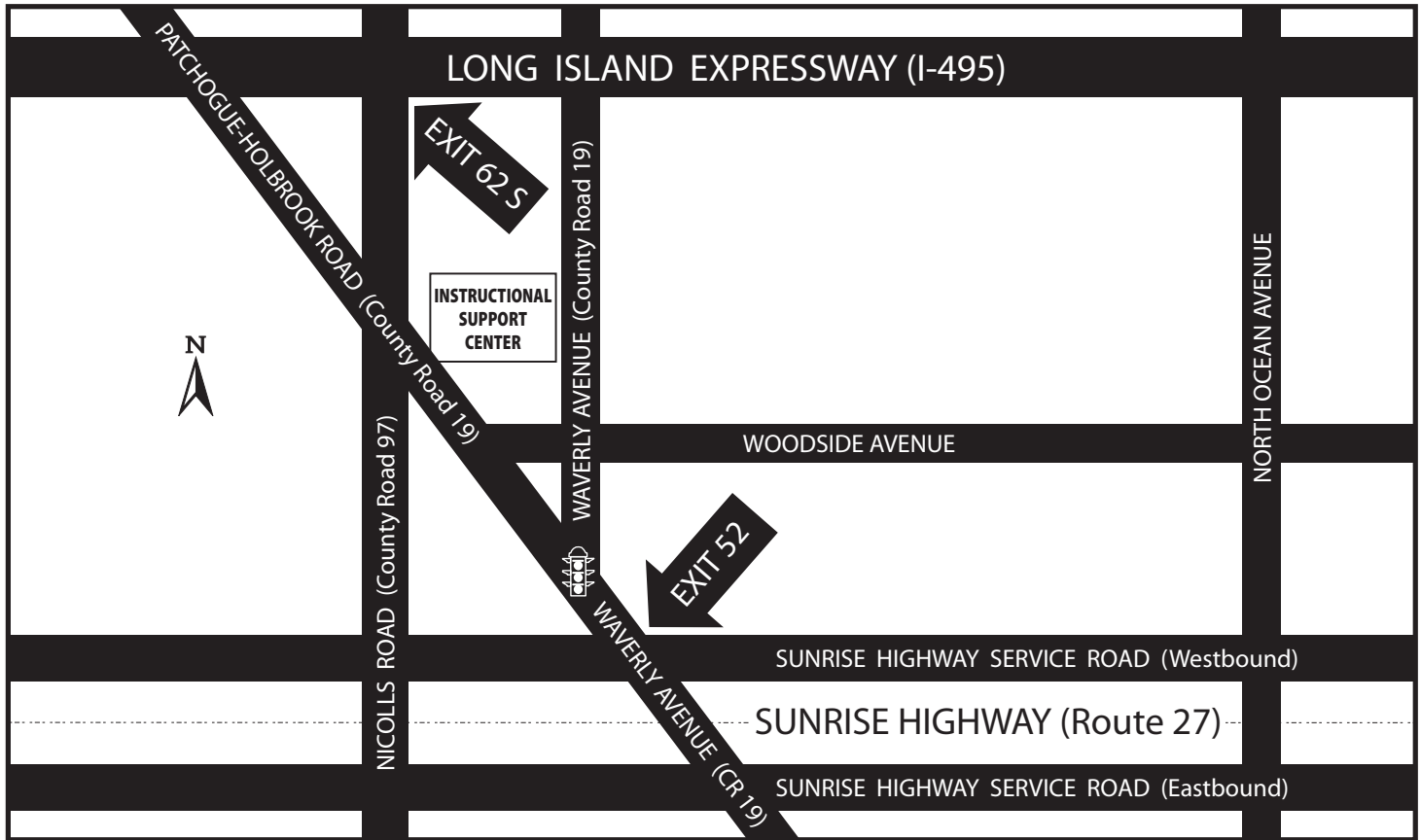

DIRECTIONS

Via Sunrise Highway (Route 27) from the West:

East on Sunrise Highway (Route 27) to Exit 52 - Waverly Avenue (County Road 19). Continue east on service road to 1st traffic light and make left onto Waverly Avenue (County Road 19). Go ½ mile (5 traffic lights) and take right turn to continue on Waverly Avenue (there is a sign at the 5th light indicating this). Go approximately ½ mile and the Instructional Support Center will be on the left. Parking field is on the right. Follow footpath to main entrance.

Via Sunrise Highway (Route 27) from the East:

West on Sunrise Highway (Route 27) to Exit 52 - Waverly Avenue (County Road 19). Continue west on service road to first traffic light, make right onto Waverly Avenue (County Road 19). Go ½ mile and take right turn to continue on Waverly Avenue (there is a sign at the 4th light indicating this). Go approximately ½ mile and the Instructional Support Center will be on the left. Parking field is on the right. Follow footpath to main entrance.

Via the Long Island Expressway (I-495) from the East or West:

From east or west on Long Island Expressway, take Exit 62 South - Nicolls Road (County Road 97). Take the Patchogue-Holbrook Road (County Road 19) exit off of Nicolls Road. Make left at the traffic light and continue on Patchogue-Holbrook Road (4 traffic lights). Make a left onto Waverly Avenue, go approximately ½ mile and the Instructional Support Center will be on the left. Parking field is on the right. Follow footpath to main entrance.
