- Update on School Uniform Dress Code Discussion & Student/Staff Advocacy

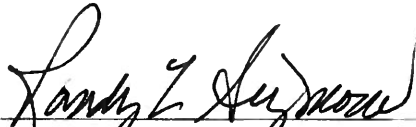
TREASURER’S REPORT

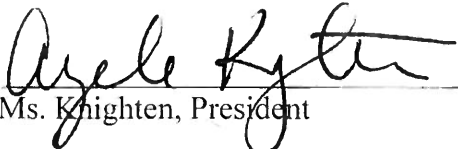
There being no further business, President Knighten declared the meeting adjourned at 9:44 p.m.
