Program Overview for Parents, Students & Community

High School Summer Credit Recovery Program courses are offered for students who need to recover credits for failed courses.

The Summer 2026 program will offer credit recovery opportunities for required courses in the following content areas: ENGLISH LANGUAGE ARTS, MATH, PHYSICAL EDUCATION & HEALTH, ESL (English as a Second Language), WORLD LANGUAGE, SCIENCE & SOCIAL STUDIES, as well as other course options.

Paterson Public Schools students are asked to utilize their district-issued computer or "Chromebook," as a computer with internet access is required to participate successfully.

Who Is Eligible?

Paterson students/residents in grades 9-12 who have taken and failed a course required for graduation and have received notification of eligibility. This program is open to all students meeting the above criteria, including those students who require accommodations and/or modifications.

Notification of Eligibility

Beginning June 12, 2026, eligible/qualifying students and their families will be notified of their request to enroll in summer credit recovery by either of the following measures:

- Email sent to students' "students.patersonschools.org" account
- Letters mailed to the student's home address on file with the district
- Information provided by school counselors

Student Experience

Students will be provided with no more than two (2) classes.

Students must attend classes daily. Students with multiple absences will be dropped from the program. Students are required to bring their fully-charged District-issued Chromebooks, notebooks and a writing utensil each day.

Students will be able to work independently on both their teacher-assigned work, as well as their Edgenuity course outside of the regular scheduled day. Edgenuity is a self-paced online application that will track student progress and mastery of a particular course. Students will have the ability to work on their Edgenuity course at their availability at any time (day/night/weekday/weekend) throughout the program duration. All assessments must be completed in person during the school day.

Teachers will provide instruction and assistance with Edgenuity and Google Classroom content, as well as provide tutoring and pacing, as needed.

How Students Complete/Pass a Summer School Course

- 1) Students must complete 100% of the assigned course content.**

Roles & Responsibilities of Summer School-affiliated Personnel

Program Administrators

- Create/assign teacher schedules in advance of program start
- Provide support to teachers with Edgenuity
- Provide supervision to assigned faculty and staff
- Supervise teacher lessons, student learning in Google Classroom
- Track student progress
- Monitor student attendance
- Review, approve teachers' weekly lesson plans
- Monitor teacher's outreach logs; follow up with students/families as needed
- Assist, as needed, by the Director of Secondary Education

Program Technology Coordinator

- Create a new "naming convention" for Edgenuity courses, to ensure clarity on Summer School designation
- Monitor all aspects of Edgenuity platform; troubleshoot and assist all stakeholders as needed
- Assist Program administrators with weekly information from Edgenuity
- Assist, as needed, by the Director of Secondary Education

Program Counselors

- Review student transcripts, grades, and course requests to verify the courses students need for Summer School
- Assign courses to Infinite Campus
- Upon program completion, review transcripts for accuracy and appropriately code seniors
- Provide the Director of Secondary Education with a final Grad list for the summer program
- Assist, as needed, by the program administrators, Director of Secondary Education & Director of Guidance

Program Teachers

- Plan and implement daily lessons (Monday-Thursday) during posted/scheduled times
- Submit weekly lesson plans to the assigned Program Administrators
- Plan, assign, grade, and provide feedback for supplementary assignments to students' Edgenuity coursework (two per week, total of 8)
- Plan with students, as needed, small-group tutoring
- Maintain grade book of supplemental assignments
- Maintain accurate daily attendance
- Monitor students' Edgenuity coursework progress
- Schedule and perform daily outreach to students/families, as needed
- Maintain a communication log for parent/student outreach
- Maintain grade book for 8 assignments
- Provide access to the Program Administrator to their Google Classroom if needed for course
- Provide information, as needed, to the Site Administrators

Program SAC

- Follow Substance Abuse policy and maintain records of any occurrences.
- Assist, as needed, by the program administrators, Director of Secondary Education & Director of Guidance
