**Affidavit along with all proofs of residence are due each school year.**

**Custodial Parent/Guardian must annually provide any two (2) of the following proofs of residence documents verifying that you live at the address (documents must be dated within thirty (30) days of enrollment):**

- \_\_\_\_\_ **Driver's License or State Issued ID** – must have current address or BMV statement showing change
- \_\_\_\_\_ **Payroll Check or Paystub** – must include name, current address, and current date
- \_\_\_\_\_ **Job & Family Services Letter or Letter from Caseworker** – must include name, current address and current date
- \_\_\_\_\_ **Income Tax Documents** – must be for the current year and have been filed within sixty (60) days of the Adult Resident Affidavit application
- \_\_\_\_\_ **US Postal Service – Proof of Address Change** – must include name, current address, be date stamped by the post office, or can be completed online with USPS
- \_\_\_\_\_ **Court Document** – must include name, current address, and current date
- \_\_\_\_\_ **Documentation on Employer's Letterhead verifying the Address** – must include name, current address, and current date
- \_\_\_\_\_ **Social Security Statement** – must include name, current address, and current date

**AND, the Renter or Home Owner needs to annually provide two (2) proofs of residence documents verifying they are the owner/renter of the property.**

- \_\_\_\_\_ **REQUIRED: Lease Agreement, Mortgage Payment Coupon, or Deed** – must be current, in the homeowner's or renter's name, with address of property
- \_\_\_\_\_ **Electric bill, Gas/Oil bill, Water bill, Home Owner or Renters Insurance** – must include name, current address, and current date (no disconnection notice will be accepted)

**\*Residency Affidavits are investigated thoroughly throughout the year.** We retain the right to speak with employers, rental agencies, neighbors, telecommunications, utility providers, and law enforcement about your residential location.

**\*At any time during the year, the truancy officer and school retain the right to request updated residency documentation to verify a residency dispute.**
