# School Tax Credit Form

**What is a tax credit?**

A tax credit is **NOT** a donation! It **IS** a dollar-for-dollar reduction in the state income tax you pay. If your tax credit contribution is more than the amount of state tax you owe, the credit can be carried forward for up to five years. Receiving this tax credit will allow you to reduce the amount you owe the state or increase your refund. When filing your income tax return for the State of Arizona, the amount you designated to your school will be the amount you may claim as a state tax credit. This payment is eligible for Arizona state income tax credit as allowed by A.R.S. §43-1089.01. Tax credit contributions are non-refundable.

**Designate your Tax Dollars to help Students of Scottsdale Unified School District #48**

It's a win-win situation for you and the school! Contributions received from January 1, 2026, through April 15, 2027 can be claimed on your Arizona State tax return for either 2026 or 2027.
