We are pleased to present to you this year's Annual Drinking Water Quality Report. This report is designed to inform you about the water quality and services we deliver to you every day. Our constant goal is to provide you with a safe and dependable supply of drinking water. We want you to understand the efforts we make to continually improve the water treatment process and protect our water resources. We are committed to ensuring the quality of your water.

Landlords must distribute this information to every tenant as soon as practicable, but no later than three business days after receipt. Delivery must be done by hand, mail, or email, and by posting the information in a prominent location at the entrance of each rental premises, pursuant to section 3 of P.L. 2021, c. 82 (C.58:12A-12.4 et seq.).

Our source is 2 ground water wells that draw water from the Raritan Aquifer, over 200 feet deep.

KINGSWAY REGIONAL HIGH SCHOOL SOURCE WATER ASSESSMENT

Kingsway Regional High School routinely monitors for constituents in your drinking water according to Federal and State laws. This table shows the results of our monitoring for the period of January 1st to December 31st, 2025. As water travels over the land or underground, it can pick up substances or contaminants such as microbes, inorganic and organic chemicals, and radioactive substances. Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, EPA prescribes regulations, which limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration regulations establish limits for contaminants in bottled water, which must provide the same protection for public health.

DEFINITIONS

In the following table(s) you may find many terms and abbreviations you might not be familiar with. To help you better understand these terms we've provided the following definitions:

No Detection (ND) - Laboratory analysis indicates that the constituent is not present. The constituent(s) may still be represented in the table below as they are ones included regardless of detection. Not all undetected constituents are necessarily included in the table(s) below.

Parts per million (ppm) or Milligrams per liter (mg/L) - One part per million corresponds to one minute in two years or a single penny in \$10,000.

Parts per billion (ppb) or Micrograms per liter (µg/L) - One part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.

Part per trillion (ppt) or Nanogram per liter (ng/L) - One part per trillion corresponds to one minute in 2,000,000 years, or a single penny in \$10,000,000,000,000.

Picocuries per liter (pCi/L) - Picocuries per liter is a measure of the radioactivity in water.

Action Level (AL) - The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Maximum Contaminant Level - The "Maximum Allowed" (MCL) is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal - The "Goal" (MCLG) is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Recommended Upper Limit (RUL) - Recommended maximum concentration of secondary contaminants. These reflect aesthetic qualities such as odor,

taste, or appearance. RUL's are recommendations, not mandates.

Maximum Residual Disinfectant Level (MRDL) -The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Maximum Residual Disinfectant Level Goal (MRDLG) - The level of a drinking water disinfectant, below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contamination.

There were other contaminants that were tested in 2025, including volatile organic compounds, synthetic organic compounds (123TCP, EDB & DBCP), stage 2 disinfection byproducts (TTHM & HAA5), and Per- and Polyfluorinated Substances (PFAs: PFOS, PFNA, & PFOA). These contaminant results were not included in the table above as the results of these samples were undetectable.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not your drinking water meets health standards. During the 01/01/2025 through 06/30/2025 compliance period, we did not complete all monitoring or testing for pH at TP001001 during the 01/10/2025-01/23/2025 and 07/11/2025-07/24/2025 biweekly monitoring periods, and therefore cannot be sure of the quality of your drinking water during that time. The biweekly pH sampling was missed for these periods, resulting in two violations. A make-up sample was collected for each compliance period on 01/24/2025 and 07/25/2025, of which the result was 7.09 S.U. and 7.87 S.U. respectively. We are pleased to tell you that your pH results for Kingsway Regional are safe for drinking and these violations were due to missed samples. These violations # 2026-1630 and 2026-1631 were determined on 02/03/2026 and 06/16/2026 respectively and have since been resolved.

*Under optimal WQP monitoring a facility is allowed up to 9 days of excursions, defines as days which the pH is outside the approved WQP range, within a 6-month period. On 07/02/2025, the pH was 6.83, however, the pH was collected twice within the same biweekly period on 07/09/2025, with a result of 7.31. During the 07/01/2025 through 12/31/2025 monitoring period, the facility only had 7 excursion days, so a violation was not triggered for the 07/02/2025 sample.

ADDITIONAL INFORMATION

The Safe Drinking Water Act regulations allow monitoring waivers to reduce or eliminate the monitoring requirements for asbestos and synthetic organic chemicals (SOC). Our system received a monitoring waiver for asbestos and has been granted a SOC waiver for the 2023-2025 compliance period. We expect to receive a SOC waiver for the current compliance period upon NJDEP determination.

Health effects language: none required

As you can see from the table(s), our system had one violation for a missed biweekly pH sample. **We're proud that your drinking water meets or exceeds all Federal and State requirements.** We have learned through our monitoring and testing that some constituents have been detected. The EPA has determined that your water IS SAFE at these levels.

Please share this information with all the other people who drink this water, especially those who may not have received this notice directly (for example, people in apartments, nursing homes, schools, and businesses). You can do this by posting this notice in a public place or distributing copies by hand or mail.

We constantly monitor for various constituents in the water supply in an effort to meet ALL regulatory requirements.

MCL's are set at very stringent levels. To understand the possible health effects described for many regulated constituents, a person would have to drink 2 liters of water every day at the MCL level for a lifetime to have a one-in-a-million chance of having the described health effect.

Nitrate: Nitrate in drinking water at levels above 10 PPM is a risk for infants of less than six months of age. High nitrate levels in drinking water can cause blue baby syndrome. Nitrate levels may rise quickly for short periods of time because of rainfall or agricultural activity. If you are caring for an infant, you should ask for advice from your health care provider.

Additional Information for Lead

The system inventory does not include any lead service lines.

Kingsway Regional High School has identified all services lines to be compromised of non-lead materials. The inventory can be accessed through the main office.

Lead: Lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Kingsway Regional High School is responsible for providing high quality drinking water and removing lead pipes, but cannot control the variety of materials used in plumbing components in your home. You share the responsibility for protecting

yourself and your family from the lead in your home plumbing. You can take responsibility by identifying and removing lead materials within your home plumbing and taking steps to reduce your family's risk. Before drinking tap water, flush your pipes for several minutes by running your tap, taking a shower, doing laundry or a load of dishes. You can also use a filter certified by an American National Standards Institute accredited certifier to reduce lead in drinking water. Special Considerations Regarding Children, Pregnant Woman, Nursing Mothers, and Others:

Children may receive a slightly higher amount of a contaminant present in the drinking water than adults, on a body weight basis, because they may drink a greater amount of water per pound of body weight than do adults. For this reason, reproductive or developmental effects are used for calculating drinking water standard if these effects occur at lower levels than other health effects of concern. If there is insufficient toxicity information for a chemical (for example, lack of data on reproductive or developmental effects), an extra uncertainty factor may be incorporated into the calculation of the drinking water standard, thus making the standard more stringent, to account for additional uncertainties regarding these effects. In the case of lead and nitrate, effects on infants and children are the health endpoints upon which the standards are based.
