TUITION PAYMENTS _____ Initials

St. Paul's SAC offers an annual one-time payment or a monthly payment plan. The 9-month payment plan is paid by automatic debit F.A.C.T.S **August billing is NOT included in the 9 month payment plan but is billed separately, and prorated.** Registration and monthly fees are billed and paid through F.A.C.T.S

OVERDUE ACCOUNTS _____ Initials

A late fee of \$30 will be applied to all past due accounts. Care services will no longer be provided should an account become past due by one payment. In order to be readmitted, payment must be paid up-to-date including any SAC tuition which became due during the suspension period. All late fees must be paid.

LATE PICK UP FEES _____ Initials

School-Age-Care closes at 6:00 p.m. A late pick-up fee of \$1.00 per minute per child with no cap will be charged past 6:00 p.m. Late fees billed to your account. Unpaid late pick up fees are considered overdue accounts and will result in discontinued use of the care center
