### **NOTIFICATION TO THE COMMUNITY** **OPEN SITES**

The Lakewood Board of Education is participating in the 2026 Summer Food Service Program from *June 29, 2026 thru August 31, 2026*.

Meals will be provided to all children without charge and are the same for all children regardless of race, color, national origin, sex (including gender identify and sexual orientation), disability, age, or reprisal or retaliation for prior civil rights activity and there will be no discrimination in the course of the meal service. Meals will be provided, at a first come, first serve basis at the sites and times as follows:
