Childcare Occupations provides students with specific training for occupations such as a pre-school teacher, infant teacher, before and after school care teacher, family day care provider, foster care parent, teacher aide, camp counselor and recreation aide. Instruction includes child development, learning environment design, behavior management, working with special needs, child health and safety, trends in education, curriculum and lesson plans, laws and regulations relating to childcare services. Career preparations standards, which include basic academic, communication, interpersonal and problem-solving skills, are integrated throughout the course.
