This course provides instruction and training in automotive repair and maintenance with a specialization in electrical, electronic systems and engine performance. Hands-on training experiences will include understanding, diagnosing, and repairing automotive electrical, electronic, ignition, fuel, emission, and engine performance systems, as well as related components and controls. Experience will be provided in the use of hand tools, power tools, testing and troubleshooting equipment, scan tools, and service information. Students who achieve competency in this course will obtain entry-level skills that support employment, continued training, and preparation for relevant ASE Entry-Level Certification testing in electrical, electronic systems, engine performance, and related areas.

*a) Students plan and employ effective research strategies to locate information and other resources for their intellectual or creative pursuits.*

*b) Students evaluate the accuracy, perspective, credibility and relevance of information, media, data, or other resources.*

**5. Computational Thinker-** *Students develop and employ strategies for understanding and solving problems in ways that leverage the power of technological methods to develop and test solutions.*

*a) Students formulate problem definitions suited for technology-assisted methods such as data analysis, abstract models, and algorithmic thinking in exploring and finding solutions.*

*b) Students collect data or identify relevant data sets, use digital tools to analyze them, and represent data in various ways to facilitate problem-solving and decision-making.*

*c) Students break problems into component parts, extract key information, and develop descriptive models to understand complex systems or facilitate problem-solving.*

*d) Students understand how automation works and use algorithmic thinking to develop a sequence of steps to create and test automated solutions.*

**6. Creative Communicator-** *Students communicate clearly and express themselves creatively for a variety of purposes using platforms, tools, styles, formats, and digital media appropriate for their goals.*

*a) Students choose the appropriate platforms and tools for meeting the desired objectives of their creation or communication.*

*b) Students create original works or responsibly repurpose or remix digital resources into new creations.*

*c) Students communicate complex ideas clearly and effectively by creating or using a variety of digital objects such as visualizations, models, or simulations.*

*d) Students publish or present content that customizes the message and medium for their intended audiences.*
