Student Transportation Policy #8100

Transportation by school bus is not mandatory. This service is provided for those who wish to ride under the terms set up. Riding the school bus is a privilege and NOT a "right" and the privilege can be revoked at any time due to misconduct.

The following information for parents and students states the regulations governing riding. Rules are for the safety of students and must be followed. Non-compliance may be met by refusal to transport. It is expected that all concerned will read this handbook. In case there are questions, please call for an explanation in order that there be no misunderstanding.

The District may provide transportation to and from school for a student who:

1. Resides three (3) or more miles, over the shortest practical route, from the nearest operating public elementary or public high school;
2. Is a student with a disability, whose IEP identifies transportation as a related service;
- or
3. Has another compelling and legally sufficient reason to receive transportation services.

Transportation Services

At Laurel Public Schools, student safety is our top priority. Transportation services are provided to students who live more than three (3) miles from their school, as well as to those within three miles when specific safety concerns for walking have been identified.

Our bus routes and operations will follow a structure similar to last year. All buses meet inspection standards set by the State Highway Patrol, and our drivers are fully certified through the Montana Office of Public Instruction. We take great pride in maintaining safe, reliable transportation for our students every day.

We understand that transportation procedures can sometimes feel inconvenient. Please know that these guidelines are not intended to create hardship for families—they are designed to ensure the safety and well-being of every student on our buses. These procedures work alongside school and district policies, as the school bus is considered an extension of the classroom.

Every day, we are entrusted with what matters most—your children. We are committed to caring for them with the highest level of safety and professionalism. We appreciate your partnership, support, and cooperation as we work together to provide safe transportation for all students.

Title IX

Title IX is a federal civil rights law passed as part of the Education Amendments of 1972 in the United States, which states: “No person in the United States shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving Federal financial assistance.” This law applies to all public education institutions.

Laurel Public Schools takes violations of Title IX very seriously and will investigate all complaints immediately. If you feel your student has been the victim of a Title IX violation, whereas the harassment or discrimination is sexual in nature, you are urged to immediately reach out to your school principal or the Title IX Coordinator. When a school receives a complaint that could be a potential violation of Title IX, it is required to act promptly and effectively to investigate and resolve the complaint. The school's actions must be in compliance with Title IX regulations and guidance from the U.S. Department of Education's Office for Civil Rights (OCR) and District Policy 3225.

Here are the steps our district takes upon receiving such a complaint:

1. Immediate Action: The school takes immediate action to ensure that the parties are safe. This might involve temporary measures such as changing class schedules or providing extra support. The school will notify the Title IX Coordinator.
2. Formal Investigation: The Title IX Coordinator will initiate a formal investigation into the complaint. This investigation will be fair, impartial, and provide both parties an opportunity to present their side of the story and any evidence they have. If the Title IX Coordinator deems that it does not rise to the level of Title IX, the matter will be forwarded to the principal of the school for a Code of Conduct violation.
3. Resolution Process: Based on the investigation, the Title IX Decision Maker will determine whether a Title IX violation occurred. The determination will be based on a preponderance of the evidence (whether it is more likely than not that a violation occurred).
4. Taking Action: If a Title IX violation has occurred, the district will take appropriate action to stop the discrimination, prevent its recurrence, and remedy its effects. This may include disciplinary actions against the respondent, providing support services to the parties, and implementing school-wide training or policy changes, if necessary.
5. Right to Appeal: Both parties will be informed of the outcome of the investigation and will have the right to appeal the decision if the conditions of appeal are met as outlined in District Policy 3225.

Registration of Riders

All students must be registered as bus riders to use the school bus. The Laurel Transportation Department's Student Bus Rider Registration Form is readily available on the school website. Simply visit the site, click on 'Departments,' and then select 'Transportation.' Online registration is the only method offered, so please take advantage of this efficient option. If you require assistance, don't hesitate to reach out to the Transportation Director. Ensure that the address you provide matches the one on Infinite Campus. Parents or guardians must complete this form and submit it to the transportation office. By signing the Registration Form, you confirm that you have been informed about where to access the Laurel Public Schools Student Transportation Handbook and agree to comply with the rider policies set forth by the LPS Board of Trustees. Your cooperation is essential, and we appreciate your prompt attention to this matter.

ID/Bus Badges-Required To Ride

- How will High School bus passes work?
 - High Schoolers will use their current ID badges as their bus pass. If their badge does not work when they scan it on the bus, it likely means that they have never actually tied their badge to their PaperCut account, which is where Tyler pulls their access token from. If this is the case, please have the High Schooler follow the steps below to tie their badge to their account. After doing this, the next time PaperCut syncs with Tyler, the student's token will be input into the database and they can then use their badge as their bus pass.
 - Tying a badge to an account:
 1. Scan your badge at one of the Bizhub printers in the district
 2. After your badge has been scanned, a login page will pop up on the printer's screen. At this login page, enter your normal district credentials (firstnamelastname for username and then your standard password -- on your username, please do not add the @laurel.k12.mt.us, just firstnamelastname) and click 'Sign In.'
 3. Once signed in, your badge will automatically be linked to your account
- How do new students get their bus passes?

- High School: At the High School level, we will automatically print the student's access badge upon receiving a badge request form from one of the secretaries. We then send this badge to the High School via interschool mail. The students will then have to follow the process outlined above to tie their badge to their account.
- KB - 8th: For any new students, **the Transportation Office** will have the ID Badge/Bus Pass and hand it to the student when they first ride the bus.
- How often will students receive reprints?
 - Students will not receive reprinted bus passes, unless their pass has become defective. The passes intentionally do not have a student's picture so that it can follow them all the way through to High School, where they will then receive an access badge that will also act as their bus pass.
- Since the eighth graders will receive access badges when they start High School, what should I do with their bus passes?
 - Since the eighth graders will transition from a standard bus pass to an access badge in High School, they will no longer need their bus passes. When this occurs, we please ask that you return their assigned bus passes.
- If a student loses or damages their bus pass, how do they get a new one and will they be charged for a replacement?
 - If a student loses or damages their bus pass, the first reprint of a student's bus pass will be free. Any print after the first, they will be charged for a replacement fee. For the second reprint, the replacement fee is \$10.00. Every reprint after that will increase in cost in increments of \$5.00, maxing out at \$25.00 (example, third reprint is \$15 and fourth is \$20).
- What do I do with a student's bus pass if they have left the district?
 - If a student leaves the district, please return their badge to the bus driver.
- What do I do with a student's bus pass if they are still enrolled, but are no longer taking the bus?
 - We ask that **you** return your bus pass to the Transportation Office for safe keeping.

Transportation Transfer and Route

Bus Assignments & Stops

Students must ride their assigned bus and use their designated stop for pick-up and drop-off.

Changes to a different bus or stop are only approved in true emergencies and on a case-by-case basis. An **Emergency Rider Waiver** must be completed and approved by both the building principal and the Transportation Director before any changes are allowed.

In-Town Transfer Riders

In-town students may ride as **school-to-school transfer riders**. This allows students to:

- Ride in the morning from the school closest to their home to their enrolled school
- Return in the afternoon from their enrolled school to the school closest to their home

Students within the no-ride zone may only ride between their designated schools. Riding to a stop outside the no-ride zone is not permitted unless an approved Emergency Rider Waiver is on file.

Responsibility—Parent

The interest and assistance of each parent is a valued asset to the transportation program. Parents' efforts toward making each bus trip a safe and pleasant experience are requested and appreciated. The following suggestions are only three of the many ways' parents can assist:

1. Ensure that students are at the bus stop in sufficient time to efficiently meet the bus.
2. Properly prepare children for weather conditions
3. Encourage school bus safety at home. Caution children regarding safe behavior and conduct.
4. Register for the Parent App.

Transportation Director has the authority to place student on the grid according to offenses not specifically listed. This grid is a guide and not designed to be all-inclusive.

Responsibilities- Students

Students must realize that safety is based on group conduct. Talk should be in conversational tones at all times. There should be no shouting or loud talking which may distract the bus driver. The student should instantly obey all commands or suggestions from the driver and/or his/her bus aide.

Bus Rules:

The violation of any of the following rules will place the student into the bus discipline system. THE BUS DRIVER IS IN CHARGE OF THEIR BUS (just like the teacher in a classroom).

1. No cell phones will be allowed out of the student's backpack while on a school bus. This includes watches and other electronic devices. The school bus is just a classroom on wheels and follows the same rules.
2. Students should be respectful to the driver, aide, and other students while riding the bus. Language and gestures should be the same on the bus as it is in the classroom.
3. Students will be assigned a seat. Changes to the seat assignments can be discussed with your driver and approved by the Transportation Director. Seating charts are kept for safety reasons.
4. Students shall ride only their assigned bus. Students will only be allowed to get on or off at their assigned stop location. Permission may be granted to ride another bus or get on or off at another location on a case by case basis. This requires a parent/guardian signed form and approved by both the Principal and Transportation Director before a change can take place.
5. When requested by the driver or aide, students need to immediately and correctly identify themselves.
6. Students need to arrive at the bus stop at least five (5) minutes prior to the designated bus pick-up times and wait in a safe and orderly manner out of the roadway and off private property. Students are asked to wait to approach the bus until it has come to a complete stop and are signaled by the driver to board the bus.
7. Please enter and leave the bus in an orderly manner in view of the driver. If they must cross the road, do so in front of the bus (never behind it) and wait for the driver to signal the student when it is safe to cross.
8. For the safety of our students we ask that they remain properly seated (seat to seat & back to back) facing the front of the bus at all times. No standing, moving seats, facing backward, sitting on knees, sitting on backpack or other personal items.
9. If seatbelts are provided, please wear them and wear them correctly. It is for your safety that we enforce this rule. Wearing the shoulder strap behind you is not safe.

10. For the extended safety of our students' head, hands, arms or any other body part needs to be kept inside the bus at all times whether the bus is in motion or parked.
11. The school bus (including the bus seats) are considered District Property. Students/families are responsible for damage to the school buses resulting from student misconduct.
12. Students will refrain from excessive noise, shouting, boisterous behavior, fighting, vulgar or obscene language or gestures, racial or sexual harassment, sexual misconduct and bullying.
13. Students must not have anything in their possession that might cause injury to another, no weapons of any kind, including but not limited to knives, guns, sharps, fighting gear, etc.
14. No smoking, vaping, chewing, or spitting of tobacco or use of any type of flame or sparking devices. Illegal substances or alcoholic materials or their paraphernalia are not allowed on the school buses.
15. For safety reasons (choking and allergies) food and drink are not permissible, this includes gum, candy, pop, pastries, other types of food or confectionaries. In hot weather a water bottle with water is permitted. Exceptions to this rule only apply to documented medical needs.
16. Bus aisles must be kept clear per state law. Large items which cannot be held in the student's lap will need to be transported by other means; this includes large band instruments and football bags.

Bus Rules

- ◆ Everyone has an assigned seat! Be safe and sit back to back and seat to seat.
- ◆ Be respectful to the driver, aide and other students. Language and gestures should be the same as in the classroom.
- ◆ Seat belts will help keep you safe, please wear them correctly.
- ◆ For your safety keep your head, hands, arms, or any other body part inside the bus.
- ◆ Cell phones and other electronic devices are not allowed out on the bus.
- ◆ Quiet Zone at all Railroad Crossing!
- ◆ Be safe, please no food or drink on the bus (e.g. suckers, gum)
- ◆ Be on time and stay clear of the “Danger Zone”.
- ◆ Bus Passes are needed to load and unload the bus.



Safety and Emergency Procedures:

The Superintendent or designated representative will be responsible for canceling school bus routes due to inclement weather. The District will send an "All-Call" to households of bus students and notify the media. Bus service suspension will be for one (1) day at a time due to the weather; it will automatically begin the following day unless there is another announcement suspending the service. There will be no notices sent.

Priority will be given to getting rural students home safely during extreme weather conditions. If buses are to return early due to either a threatening storm or blowing and drifting snow, parents/guardians or emergency contacts of students will be notified before the students are released. Middle School and High School students will be dismissed at the same time as the elementary students. If a road is closed during the morning, it will be assumed closed during the evening run also unless the road has been opened by County DOT or MTDOT. If the road is impassable, it is the responsibility of the parent/guardian to make other arrangements for their student(s) to get home safely.

In the event that weather conditions become so severe after school has been in session that attempting to run buses poses a threat to the safety of children, buses will be grounded until it is safe for travel. The district will help make provisions for housing students until conditions allow bus travel or until parent/guardian is able to pick up the student.

Weather & Attendance

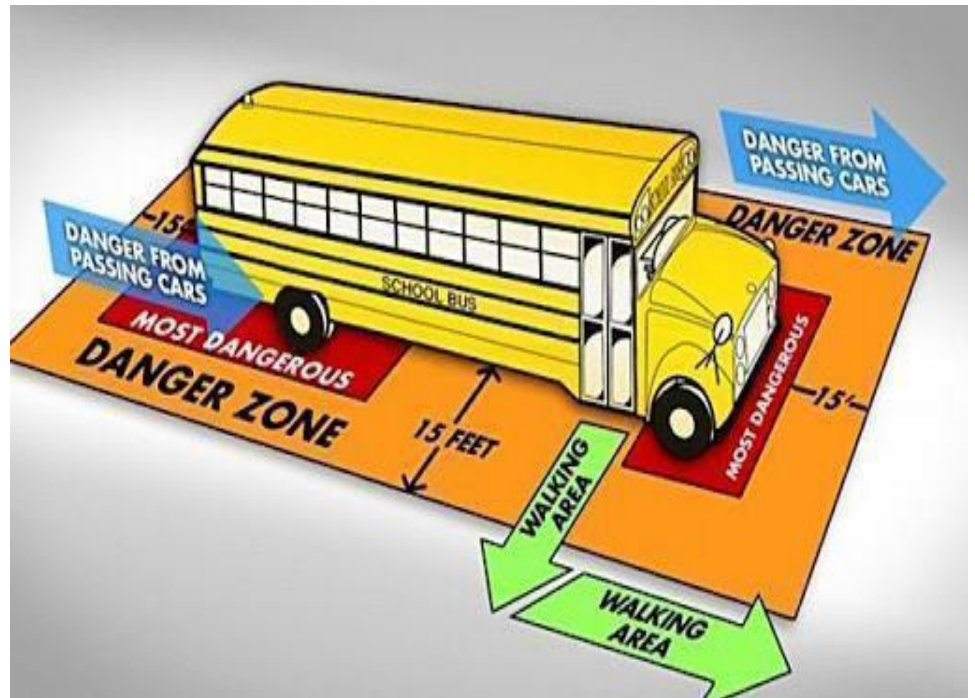
Parents/guardians always have the right to decide whether to send their student to school, even when buses are running.

If you feel weather conditions are too severe for your student to attend, please call your student out through their school.

Your judgment and your child's safety come first—we respect and support your decision.

During all driving conditions, the bus driver has the final say.

Few aspects of school bus loading and unloading are more dangerous than the appropriately named “danger zone”. The danger zone includes areas near the bus where students cannot be directly seen by the bus driver, and where incidents involving other vehicles are most likely to occur. The danger zone can be considered up to 10 feet from the bus in any direction, with the most dangerous areas being the immediate front of the bus as well as anywhere within arm's reach of the back half of the bus. Please help keep your students safe by reviewing with them the danger zone areas of their bus.
