THE BOARD SHALL DETERMINE THE DUTIES, POWERS AND COMPOSITION OF ANY SUCH COMMITTEE IN A RESOLUTION OF THE BOARD OR A COMMITTEE CHARTER ADOPTED BY THE BOARD, EXCEPT THAT THE BOARD SHALL NOT DELEGATE TO SUCH COMMITTEES THE AUTHORITY TO: AMEND OR REPEAL THESE BYLAWS; FILL VACANCIES ON THE BOARD OF TRUSTEES OR ITS COMMITTEES; AUTHORIZE DISTRIBUTIONS; ADOPT A PLAN OF MERGER; AUTHORIZE THE VOLUNTARY DISSOLUTION OF THE CORPORATION; OR ANY OTHER POWERS THAT MAY NOT BE DELEGATED. UNLESS OTHERWISE REQUIRED BY APPLICABLE LAW, THE CREATION OF A GOVERNING COMMITTEE AND APPOINTMENT OF TRUSTEES TO IT SHALL BE APPROVED BY A MAJORITY OF ALL TRUSTEES THEN IN OFFICE. THE BOARD OF TRUSTEES MAY APPOINT ONE OR MORE TRUSTEES AS ALTERNATE MEMBERS OF ANY COMMITTEE TO REPLACE ANY ABSENT OR DISQUALIFIED MEMBER DURING THE MEMBER'S ABSENCE OR DISQUALIFICATION.

ADVISORY COMMITTEES. EACH ADVISORY COMMITTEE SHALL CONSIST OF ONE OR MORE PERSONS DESIGNATED BY THE BOARD OF TRUSTEES, AND THE BOARD SHALL DESIGNATE A CHAIR OF EACH ADVISORY COMMITTEE FROM AMONG THE COMMITTEE'S MEMBERS. THE BOARD SHALL DETERMINE THE DUTIES AND COMPOSITION OF ANY SUCH COMMITTEE IN A RESOLUTION OF THE BOARD OR A COMMITTEE CHARTER ADOPTED BY THE BOARD.

ADVISORY COMMITTEES MAY NOT EXERCISE ANY POWERS OF THE BOARD OF TRUSTEES AND PERSONS WHO ARE NOT TRUSTEES MAY SERVE AS MEMBERS OF AN ADVISORY

COMMITTEE. EACH ADVISORY COMMITTEE SHALL SUBMIT TO THE BOARD OF TRUSTEES AT
