Students research a case developed by Teach Democracy and prepare for trial as attorneys, witnesses, defendants, bailiffs, and clerks. Local judges, prosecutors, public defenders, and private attorneys volunteer their time to provide guidance in courtroom procedure and trial preparation. These volunteers preside over the trials and score the events. Mock Trial provides opportunities for students to engage, collaborate, learn, and thrive in a real-world scenario.
