Board of Education Meeting Minutes ~ June 15, 2026

The Board of Education of School District 66 was convened in an open and public session on June 15, 2026, at 5:00 p.m. at the District Administration Office, 909 S. 76th St., Omaha, Nebraska.

Notice of the meeting was given by placing advance notice on the front page of the District's website no less than 48 hours in advance of the scheduled commencement of the meeting as authorized by Board Policy 1220. Notice for this meeting appeared beginning on May 12, 2026, and appeared continuously up through the start of this board meeting. Notice of the meeting was also published in the Daily Record on June 12 and 15, 2026, and on their website at omahadailyrecord.com, as well as the NE Press Association website at nepublicnotices.com. Copies of proof of publication are attached to the official minutes. Notice of this meeting and the availability of the agenda were simultaneously given to all members of the Board of Education and available to anyone at the Board of Education office. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Ms. Karnes called the Board of Education Meeting to order at 5:00 p.m. She welcomed those in attendance and confirmed that public notice had been given of the meeting under the Nebraska Open Meetings Act and that a copy of the Nebraska Open Meetings Act was posted at the meeting and on the district website, as required by law. She acknowledged that the meeting had been publicly announced and the agenda was available to any interested parties. Board Meeting attendance is noted above. The Pledge of Allegiance was recited.

Approval of Minutes

Ms. Karnes requested a motion for approval of the minutes from the Board of Education Meeting held on May 11, 2026. Mr. Yale moved for approval; Dr. Van Gelder seconded. Ms. Adams and Mr. Conway abstained. Motion carried by unanimous roll call vote. Ms. Karnes requested a motion for approval of the minutes from the Board of Education Workshop held on June 1, 2026. Dr. Van Gelder moved for approval; Mr. Yale seconded. Motion carried by unanimous roll call vote.

Treasurer's Report

Dr. Van Gelder presented the treasurer's report for May 2026 and moved for approval of expenditures in the amount of \$16,556,649; Ms. Rider seconded. May 2026 financial reports (financial statements, general fund disbursement summary and general fund check register) are included in the board documents folder.

Communications

Ms. Elizabeth Power, Director of Communications and Engagement, shared district highlights including: Elementary summer school enrollment, with 180 students participating in enrichment activities; and 308 students at the high school enrolled for both enrichment and credit recovery. Two EY summer camps for grades 5-8 through Northwestern wrapped up last week; two more are scheduled in July - one through UNL and one through the University of Iowa. WHS student Carter Pflug is one of two finalists from Nebraska who will be competing at the National High School Theatre Awards in New York City on June 22nd. WCS staff are taking time during the summer to share their expertise at regional and national conferences. A number of students, some parents and a staff member recently participated in a production of *Guys and Dolls* at the Omaha Jewish Community Center. And Westbrook Elementary is the district site for free breakfast and lunch meals for district families (children up to 18 years of age) - through July 31st.

Review of 2025-2026 District Enrollment and Demographics

Mr. Robert Aranda, Director of Student Services, provided an overview of student enrollment and demographics for the 2025-2026 school year. Overall, total enrollment of 6,134 students was down slightly (.71%) from the previous school year, though holding fairly steady over the past four years (2022-23: 6,123; 2023-24: 6,165; 2024-25: 6,178; 2025-26: 6,134). Mr. Aranda reported that projected enrollment for 2026-27 is approximately 6,200. He also noted that the District's renewed efforts in compiling accurate census data on a yearly basis will help with establishing both resident and option enrollment projections. Copies of the Executive Summary and 2025-2026 District Demographic Report are included in the board documents folder.

Human Resources Annual Report and Strategic Plan Goal 2

Dr. Andrea Haynes, Assistant Superintendent of Human Resources and District Operations, presented the Human Resources annual report and shared data as it aligns with the strategies of Strategic Plan Goal 2 - *Supported and Engaged Staff*. Dr. Haynes reviewed staff retention and demographics, and highlighted a number of programs through the District's "*Grow Our Own*" as they relate to recruitment and opportunities for professional growth for both certified and classified staff. Copies of Dr. Haynes slide presentation and the Executive Summary are included in the board documents folder.

Bond Oversight Committee - Approval of Appointment

Dr. Mike Lucas requested board approval of the appointment of Mr. Caleb McDaniel to the Bond Oversight Committee to fulfill the remainder of Mr. Sean Conway's Phase II term on the BOC. Mr. Conway was elected to the Board of Education on May 11, 2026, and thus resigned from his BOC Committee seat. Mr. Yale moved for approval; Ms. Adams seconded. Motion carried by unanimous roll call vote. A copy of the Executive Summary is included in the board documents folder.

Board Policies for Approval - #1220 and #5230

Mr. Nick Lesiak, In-House Legal Counsel, presented revisions to two existing policies for approval that were initially presented for board discussion and consideration on May 11, 2026.

#1220 - Public Meetings: Agendas, Notifications, Weather Delays & Minutes (Board of Education)

LB 596 amends the Open Meetings Act's notice requirements. Previously, notices of board meetings were required to be published in the newspaper, with several exceptions. Now, notices of regular meetings only need to be published four times per year. Dr. Van Gelder moved for approval; Mr. Conway seconded. Motion carried by unanimous roll call vote.

#5230 - Graduation: Class of 2025 and beyond (Students)

LB 296 amended Nebraska's graduation statute to provide an exception for students who, at some point during their high school career, were under the supervision of a juvenile court. These changes to Policy 5230 incorporate this new statutory exception into the graduation criteria. Ms. Rider moved for approval; Mr. Yale seconded. Motion carried by unanimous roll call vote.

Board Policy for Review - #4770

Mr. Lesiak presented revisions to one existing policy for board consideration and discussion:

#4770 - Recognition of Employee Organizations (Personnel)

LB 429 requires the District to provide equal access to any professional employees' organization (as defined in the policy and statute) if the same access is given to one professional employees' organization. These changes reflect this new requirement.

Policy 4770 will be presented for approval at the Board of Education Meeting on July 13, 2026. Copies of the policy and the Executive Summary are included in the board documents folder.

Personnel Report: Employment Actions Related to the Contracts of Certified Staff Members

Dr. Haynes presented the personnel report (one certified staff resignation) for board approval. Dr. Van Gelder moved for approval; Mr. Conway seconded. Motion carried by unanimous roll call vote. A copy of the personnel report is included in the board documents folder.

Review and Approval of Superintendent Succession Plan (Policy 2115)

Ms. Karnes presented the Superintendent Succession Plan for board approval. The Board of Education Succession Planning Committee (President, Vice President and Immediate Past President) previously reviewed the Superintendent Succession Plan. With the exception of the revision to the plan year to reflect 2026-2027, there are no other changes. Mr. Conway moved for approval; Mr. Yale seconded. Motion carried by unanimous roll call vote. Copies of the Executive Summary, policy 2115 and the 2026-2027 Superintendent Succession Plan are included in the board documents folder.

Acknowledgement of Receipt of Conflict of Interest Agreement (Policy 1115)

Ms. Karnes confirmed that a signed copy of the Conflict of Interest Agreement has been submitted by each board member. This agreement (kept on file in the Superintendent's office) is signed by every board member - in even years following board elections - at the annual June organizational meeting. Copies of the Executive Summary and Policy 1115 (Conflict of Interest Agreement) are included in the board documents folder.

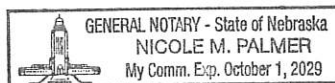

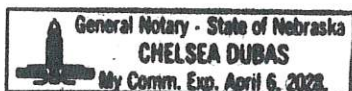
