Illinois School Health Requirements 2026-2027 School Year

All students starting Kindergarten, 6th, and 9th grades **MUST** have an Illinois physical exam and up-to-date immunization record on file for attendance at school.

Physical exams must be dated on or after August 12, 2025 for the 2026/2027 school year.

Preschool:

- **Physical exam** on an Illinois form with immunizations is required every 2 years while in preschool.
- **Complete up-to-date immunization record** including: 4 doses of *DPT/Dtap* vaccine, 3 doses of *Polio* vaccine, 1 dose *Hib* vaccine, 1 dose *MMR* vaccine, 1 dose *Varicella* vaccine, 3 doses *Hepatitis B* vaccine, and primary series of *Pneumococcal* vaccine.

Kindergarten:

- **Physical exam** on an Illinois form within one year prior to the first day of school with an updated immunization record including: 2 doses of the *Varicella* vaccine, 2 doses of the *MMR* vaccine, 4 doses of the *Polio* vaccine, 4 doses of the *DPT/Dtap* vaccine. **Due August 12, 2026.**
- **Dental Exam** on an Illinois Dental Exam form dated between November 15, 2025–May 15, 2027, and turned in by **May 15, 2027.**
- **Vision Exam** by an Eye Doctor on an Illinois Eye Exam form completed within the previous year and turned in by **August 12, 2026.**

1st Grade: No additional physical/immunization requirements if up-to-date.

2nd Grade:

- **Dental Exam** on an Illinois Dental Exam form dated between November 15, 2025- May 15, 2027 and turned in by **May 15, 2027.**

3rd, 4th, and 5th Grade: No additional physical/immunization requirements if up-to-date.

6th Grade:

- **Physical Exam** (*Sports Physical form NOT acceptable*) must be on the State of Illinois Certificate of Child Health Exam form and done within one year prior to the first day of school with up-to-date immunizations including above immunizations AND 1 dose of *Tdap* vaccine and 1 dose of *Meningococcal* vaccine after 11th birthday (If your child turns 11 after August 12, you must submit proof of an upcoming scheduled appointment). **Due August 12, 2026.**
- **Dental Exam** on Illinois Dental Exam form dated between November 15, 2025- May 15, 2027. **Must be turned in by May 15, 2027.**

7th and 8th Grade: No additional physical/immunization requirements if up-to-date.

9th Grade:

- **Physical Exam** (*Sports Physical form NOT acceptable*) must be on the State of Illinois Certificate of Child Health Exam form and done within one year prior to the first day of school with up-to-date immunizations, including those listed above. **Due August 12, 2026.**
- **Dental Exam** on Illinois Dental Exam form dated between November 15, 2025- May 15, 2027. **Must be turned in by May 15, 2027.**

10th and 11th Grade: No additional physical/immunization requirements if up-to-date.

12th Grade:

- 2nd dose of Meningitis vaccine received on or after 16th birthday. Due August 12, 2026.

New students enrolling in an Illinois School for the first time:

***Required regardless of grade level**

- **Physical Exam** with up-to-date immunization in compliance with Illinois immunization requirement (see above) due within 30 days of enrollment to the district.
- **Dental Exam** on an Illinois Dental Exam form due within 30 days of enrollment in the district.
- **Vision Exam** by an Eye Doctor on an Illinois Exam Form due within 30 days of enrollment in the district.

All exams: Physical Exam, Dental Exam (IL Dept. of Public Health Dental Exam Form), and Vision Exam (IL Eye Exam Report Form) should be done on the Illinois exam forms available on the school website.

Parents/Guardians *must* complete and sign the Health History Section on the back of the physical exam before turning it in.

Important Note: If unable to meet the above deadline due to birthdate, health restrictions, or appointment availability, an appointment card should be submitted to the district nurse.

Religious/Medical Exemptions: If your child does not receive immunizations for religious or medical reasons, an Illinois Certificate of Religious/Medical Exemption to Required Immunizations form must be completed by August 12, 2026. *Doctor signature is required.*

Sports Physicals: If your child will be trying out for any sport, they must have a sports physical on file prior to try-outs. A school physical exam may be used in lieu of a sports physical; HOWEVER, a sports physical CANNOT be accepted as proof of a physical exam for the mandated grade-level physical exam. School physical exam (Certificate of Child Health Exam Form) is valid for 365 days from issued, and the Sports physical (Sports exam form) is valid for 395 days from date issued. *TIP: Have the doctor complete both the school physical exam form and sports exam form so you are covered for school and sports requirements!
