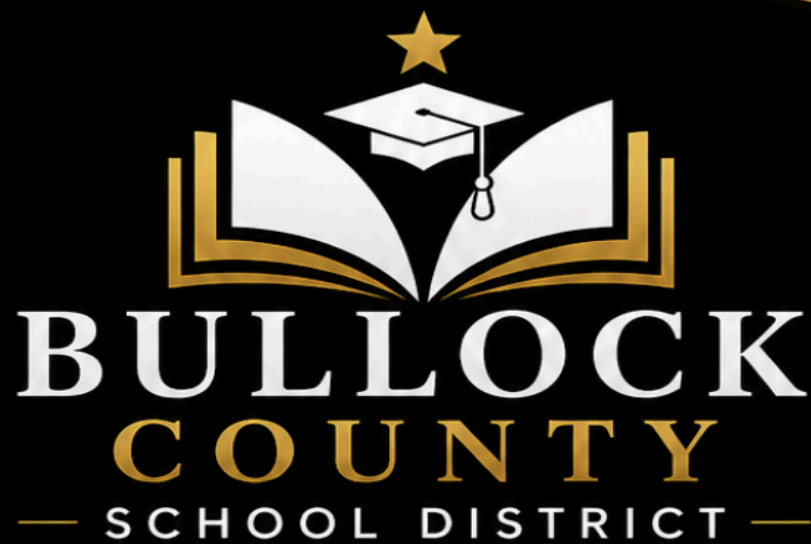

The Bullock County School District will encourage parents to be actively involved in their child's education, both at school and at home, by conducting surveys of parents and stakeholders to gain an understanding of their needs, strengths, and weaknesses. This will support their child's academic growth. Areas of concern will be addressed through oral discussions, workshops, training sessions, and parent conferences.

The Bullock County School District will host workshops and trainings at various times and days of the week to accommodate all parents and families. Workshop materials and resources will be provided free to parents. Parents will be allowed to discuss ways to improve parent and family engagement through oral discussions and surveys. GED classes are available to help parents earn their high school diploma. The district translator/Masterwork and or translation devices will be available to assist Spanish-speaking families during workshops, training, and parent conferences. The BCSD will offer assistance upon request (braille, sign language, etc.). Parent Meetings and training will be provided at local community centers, churches, and recreational centers. Virtual meetings and on-site training will be offered to parents, families, and community members.

The BCSD will provide opportunities for parents to

The BCSD will provide schools and classrooms that are warm and inviting to help families feel welcome. The Parent Center is available to assist parents with materials and resources needed to assist their child at home. BCSD will create opportunities for conversations and interactions with families to maintain communication on how the families and schools can unite to support their child's education. School administrators and teachers will keep parents informed about their child's progress and provide ways for parents to enhance their child's learning. Parent conferences will be held at least four times during the school. Parents may call and request parent-teacher-administrator conferences when they deem necessary.

The BCSD will disseminate parent surveys to parents to determine the effectiveness of the Parental Engagement Program. Parents will provide input about the plan regularly, and revisions will be made accordingly.

BCSD will take the necessary steps to ensure that communications for all parents are in a format and, to the extent practicable, in a language parents can understand. Information for parents will be translated to ensure that all parents have the opportunity to participate in their child's education. The district's translator, translation devices, and/or Masterwork will assist Spanish-speaking parents and families at workshops, conferences, and parent-teacher meetings. Teachers will utilize translation sites and apps to help students with classwork and facilitate discussions with parents. Some school forms and documents will be translated into multiple languages.

Parents and Families will be allowed to request additional support by communicating with their child's teacher or principal or directly contacting the Federal Programs Department. PDAC members may provide advice on all matters related to parent engagement. The PDAC is always open to accepting new members. Teachers may also request additional parental support or resources when students are struggling in class. Parents will periodically receive surveys to complete, which will help determine exactly what areas they desire support in.

M. Describe how the LEA may involve parents in the development of training for teachers, principals, and other educators to improve the effectiveness of such training.

BCSD will solicit parents, family members, and/or stakeholders to be involved in the development of training for teachers, principals, and other educators, aiming to improve the effectiveness of the training by requesting resources and services verbally. Parents will enhance their knowledge of their child's needs better to assist their child's learning and behavioral styles. Surveys will be disseminated, or open discussions will be held after each training session or workshop to solicit parents' opinions on the workshops and ways to improve them.

BCSD will use Title I funding to cover reasonable and necessary expenses associated with local parental engagement activities, enabling parents to participate in school-related meetings and training sessions. The BCSD will utilize contracts with speakers to engage with parents on ways they can be involved in their child's education. The PDAC members, teachers, administrators, and central office staff will be asked to recruit additional parents to join the council.

To build upon our current parental support and engagement, the BCSD offers workshops, training, and meetings at various times, days, and locations. BCSD will work toward holding meetings and trainings in community facilities, such as recreational centers, churches, town halls, parks, and businesses. Virtual training and meetings will allow more parents to participate in the comfort of their own homes.

Each school completes school improvement plans that contain a parental involvement section, which is continually reviewed and updated. This section is sent home for parents to review and modify if necessary. We will partner with schools within the district to provide parent workshops. These workshops may be held at schools, local churches, community centers, and/or parks. We have partnered with the Bullock County Department of Human Resources.

The BCSD has established a District Parent Advisory Council (DPAC), which is comprised of principals, teachers, parents, students, and community citizens. The DPAC will serve as the decision-making body of each school. The PSAC will meet quarterly to develop, review, and offer suggestions for improving the schools' and district plans. The PSAC will review data, discuss strategies implemented, and evaluate progress made by students on state assessments.

Community-based organizations are involved in the school's daily operations and are encouraged to participate in parental activities. We invite community-based agencies and organizations to the schools and parent meetings to discuss how they can support the district.
