TAKE HOME POLICY

Students in grades 7-12 will be allowed to take their assigned Chromebooks home. Students in grades K-6 will be assigned Chromebooks; however, they will not be able to take the devices home - the devices will remain at school and will be kept in the classroom. Beginning with the 2025-26 school year, loaner Chromebooks and chargers will only be issued when a student's Chromebook or charger has been submitted to the Technology Department for repair due to technical or mechanical complications. Loaner devices will no longer be issued under the following circumstances, including but not limited to, being left at home or having insufficient charge.

LIABILITY

The Crivitz School District reserves the right at any time to demand the return of an issued Chromebook. This agreement ends on the last calendar day of the school year when a device is returned, unless the agreement is terminated earlier. Failure to return a Chromebook to the issuing principal or designee on, or before, the assigned date may result in criminal charges brought against the student and/or the person in possession of the device. In the event of theft, vandalism and other criminal acts, the student or parent/guardian MUST file a police report within 48 hours of the occurrence. Incidents occurring off-campus must be reported to the police by the parent/guardian and a copy of the report provided to the school. Students will be charged the fair market value of the Chromebook if lost, stolen, deliberately damaged or vandalized. All equipment (i.e. chromebook, charger, cloth carrying bag) is assigned to each individual student at the beginning of each school year. The student/family is responsible for the assigned equipment and it must be that equipment which is returned at the end of each school year. Students will not be issued a new chromebook, charger, or case until their originally issued equipment is returned in good working order or is paid for in full if lost or damaged.

APPROPRIATE USE

- Every Chromebook is dedicated and assigned to each individual student. A student's dedicated Chromebook is to be used ONLY by the assigned student. In addition, any individual who is not the assigned student is prohibited from using any district-owned device. The assigned student and/or family will be held responsible for all activity and any misuse that occurs on the Chromebook.
- All students are required to use their school-issued Chromebook throughout all school instructional days. Personal electronic devices, including, but not limited to, laptops, desktops, and Chromebooks, are prohibited during school hours. This policy is put in place to ensure a secure and productive working environment for our students.
- If a user commits an unconventional infraction, as determined by the District Technology Coordinator or the Principal, or incurs repeated violations, all technology privileges can be revoked for any duration, including permanently.
