

WHITE SETTLEMENT ISD POLICE DEPARTMENT 2026-2027 Vehicle Rules & Regulations

1. All students who drive vehicles on campus must purchase a parking sticker; they will be issued for \$35.00. Students must present a valid driver's license and provide car insurance and know the vehicle's license plate. An additional permit will be \$20 each! Two permits only per student. If you get a new car, bring your sticker in from your old car from the same school year for no charge.
2. Students will park only in student-designated spots. Cars with proper permits are the only ones that may park in those spots. White striped painted lines - Student Parking; Yellow striped painted lines - Faculty/Staff Parking; Blue striped painted lines - Disabled Parking. Visitor's Parking - marked Visitor. **Enrolled Students Are Not Visitors.**
3. All stickers **must** be on the **lower passenger corner of the front windshield** opposite the inspection sticker, and **all stickers must be permanently affixed to the car.** No sticker may be attached with tape or laid on the dash.
4. No parking in Faculty lot or any marked Faculty spot. If you are illegally parked, **it is a violation.** All areas will be policed. **THE WEST SIDE OF THE BUILDING IS STUDENT PARKING ONLY THE SOUTH AND NORTH SIDE OF THE BUILDING IS FACULTY PARKING ONLY.** The loading zone in the front of the school is for visitors, school vehicles or deliveries, not student parking. Any student in violation is subject to discipline.
5. **Once your car is parked, it is off limits until your school day ends.** Leave your vehicle and go to the building area immediately. Do not go to your vehicle or sit in your vehicle during lunch period.
6. Temporary stickers are issued as approved by the campus safety officer. If you drive a different car to school for the day, come by the Police Office, A134, to receive a temporary permit for that day.
7. WSISD will not be responsible for loss of property or damage to auto due to theft, vandalism, or accident.
8. The person issued the permit must pay applicable fines to WSISD PD. The owner of the permit is responsible for parking and moving violations received by the vehicle bearing the permit while the vehicle is on WSISD property. **Failure to pay fines is grounds for suspension of driving/parking privileges and may result in a hold on the student's records and/or transcript.**
9. **Parking violations will be issued for the following:**

No parking permits	\$45.00
Fraudulent sticker	\$60.00
Parked in Handicap Zone	\$50-\$250
Parked in Faculty Zone (anytime between 8am to 4pm Mon-Fri)	\$20.00
Parked in Visitor Zone	\$20.00
Blocked Fire Lane	\$40.00
Blocked Driveway	\$30.00
No Parking Zone	\$20.00
Obstructing Traffic	\$40.00
Parking in areas not designated for parking	\$20.00

Two violations of the listed offenses will result in double fines and/or car being removed from the Brewer High School campus. Other violations will be referred to Municipal Court.

10. **WSISD Police Department will not be enforcing someone parked in a reserved/painted parking spot.** You can contact Ms. Cramer who is over the reserved spots.

Vehicles may be towed from the campus at the owner's expense for:

- Repeat violations of parking rules & regulations
- Parking on the inner campus service road or walkways
- Blocking a fire lane or driveway
- Causing a safety hazard or obstructing traffic
- Abandoned vehicle
- No D.L.

ALL VEHICLES ON SCHOOL DISTRICT PROPERTY ARE SUBJECT TO SEARCH

Texas Education Code - EDUC § 37.102. Rules; Penalty

(a) The board of trustees of a school district may adopt rules for the safety and welfare of students, employees, and property and other rules it considers necessary to carry out this subchapter and the governance of the district, including rules providing for the operation and parking of vehicles on school property. The board may adopt and charge a reasonable fee for parking and for providing traffic control.

(b) A law or ordinance regulating traffic on a public highway or street applies to the operation of a vehicle on school property, except as modified by this subchapter.

(c) A person who violates any rule adopted under this subchapter providing for the operation and parking of vehicles on school property commits an offense. An offense under this section is a Class C misdemeanor.

When considering a search of a student's vehicle at school, a warrant is not needed. If a school employee is a person conducting the search, then he or she only needs reasonable suspicion for a search.

If a police officer were conducting the search, then the probable cause is needed. In many cases, a school resource officer is a police officer. If a search of a student's vehicle is based on law enforcement information, then the probable cause must be present. If the search was directed by the administrator of the school, then reasonable suspicion is needed.
