Ongoing professional development and instructional coaching will strengthen teacher effectiveness by building capacity in high-impact instructional practices, assessment literacy, technology integration, and student engagement strategies. Teachers will use formative assessments and progress-monitoring tools to adjust instruction and provide timely interventions.

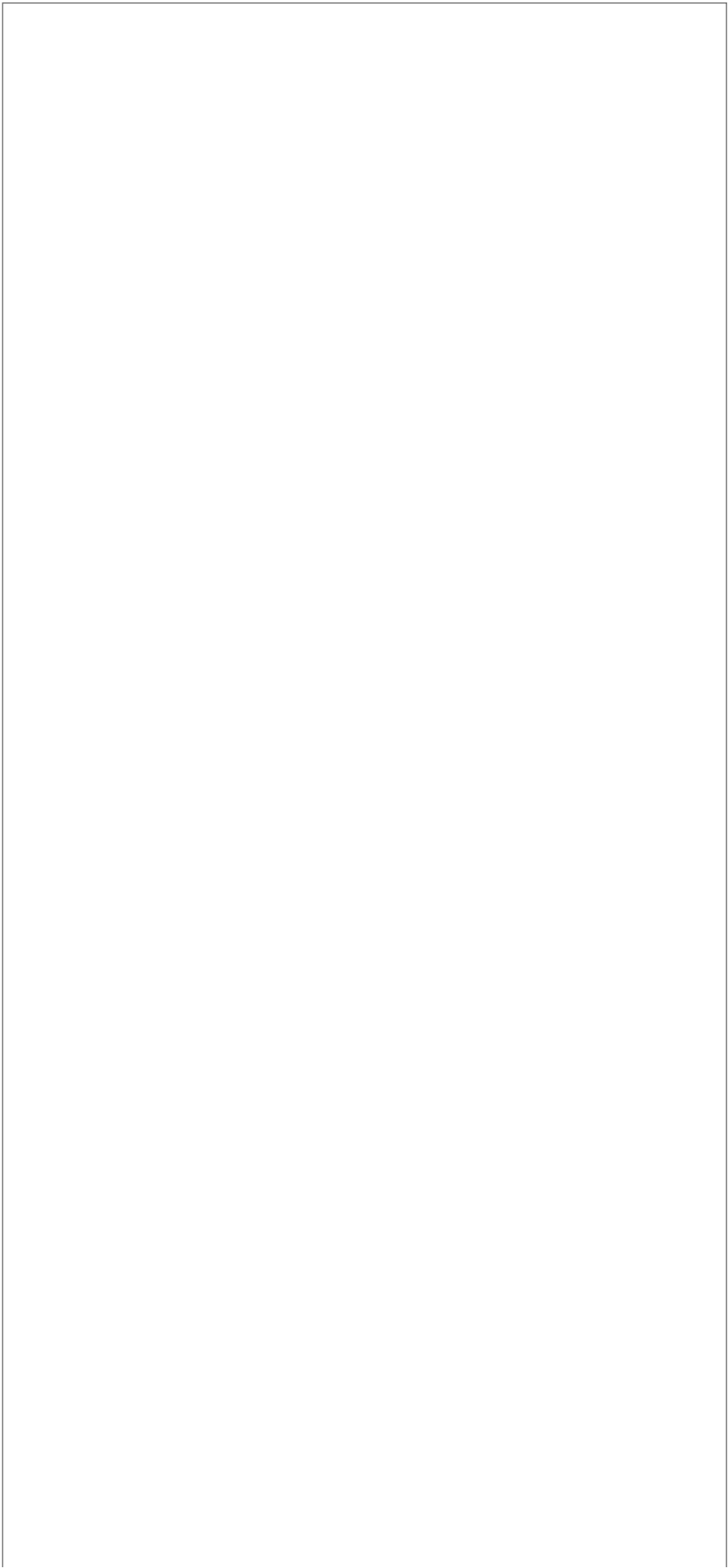
