



Parent and Family Engagement Policy - 2026-2027

1.  - Gonzales Staff will communicate with families through digital messages, family engagement nights, PTA, phone calls, student planners, family conferences, and face-to-face collaboration meetings.
 - Through a 'Parent Orientation/Open House' in August, the Parent and Family Engagement Policy will be presented, reviewed, and revised with parent feedback.
 - The Gonzales parent-family engagement policy is reviewed multiple times a year during family engagement events and at the beginning and end of each school year. The role of families in this process is to advocate for their student needs through collaboration and communication to enhance this engagement policy.
 - Through various campus events, the vision of Gonzales Elementary will be communicated: "where every student is provided a high-quality education with strong foundational skills to become life-long learners through the partnership of families and community."
2. Gonzales Elementary shall convene an annual meeting at a convenient time, to which all parents of participating children shall be invited and encouraged to attend, to inform parents of their school's participation under this part and to explain the requirements of this part, and the right of the parents to be involved; Section 1116 (c)(1)
 - Describe where and when the two annual meetings in the fall – the meeting is repeated (two per TEA – a new requirement for schools, training or guidance is needed) will convene, how parents will be notified, and what person(s) is responsible for conducting those meetings.
3. Gonzales Elementary shall offer a flexible number of meetings, such as meetings in the morning or evening; Section 1116 (c)(2)
 - Gonzales will host multiple family engagement nights in the fall and spring semesters.

 - Parent-Teacher Association Meetings:
We encourage all families to join PTA and take an active role in all activities at the campus. The PTA President will determine additional PTA meetings, and invitations will be sent to all families.

4. 5. Gonzales Elementary shall provide parents of participating children—
 - (A) timely information about programs under this part;
 - (B) a description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the achievement levels of the challenging State academic standards; and
 - (C) if requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practicably possible;Section 1116 (c)(4)
 - **Fall Parent Teacher Conferences: September 14-October 14**
 - **Spring Parent Teacher Conferences: February 8- March 8**
Fall/Spring Teacher Conferences- will have discussions with parents as to student attendance, behavior, quality of classwork assignments, student performance of curriculum standards, I-Ready, ST Math performance and progress, performance goals by subject, and areas of improvement needed.
 - Progress Reports every nine weeks and quarterly report cards.
6. If the schoolwide program plan (Campus Improvement Plan, CIP) under section 1114(b) is not satisfactory to the parents of participating children, submit any parent comments when the school makes the plan available to the local educational agency. Section 1116 (c)(5)
 - A flexible number of parent involvement meetings will take place to review the Campus Improvement Plan.
 - All families are welcome and encouraged to review the Campus Improvement Plan located on the Gonzales Elementary website and provide any comments or feedback to the campus principal through email, phone call, or meeting.

7. To ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, Gonzales Elementary shall: Section 1116 (e)

 - Family engagement nights will allow families to partner with Gonzales to learn strategies, collaborate with other families, and provide feedback to support their child from home with literacy, technology, and math.
 - Families will be provided with student data and progress by the classroom teacher.
 - (iii) educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school; Section 1116 (e)(3)
 - (iv) to the extent feasible and appropriate, coordinate and integrate parent involvement programs and activities with other Federal, State, and local programs, including public preschool programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children; Section 1116 (e)(4)
 - (v) We will provide reasonable support for parental involvement activities as parents may request. Section 1116 (e)(14)
 - We train staff to ensure that all students are receiving learning at their level and pace while still receiving grade-level instruction. This helps to ensure family/school partnerships and maximum student growth.
 - Gonzales Staff is expected to collaborate with families through campus activities such as, Engagement Nights, Meet the Teacher breakfast, STEAM Night etc.
