Parent Right-to-Know Notification

Parents' Right to Know Professional Qualifications of Teachers and Paraprofessionals

Date: August 3, 2026

Dear Families,

In accordance with the requirements of the Every Student Succeeds Act (ESSA), we are committed to keeping our families informed about their children's education.

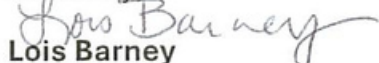
As a parent or guardian, you have the right to request information regarding the professional qualifications of your child's classroom teacher and/or paraprofessional who provides instructional services to your child.

Upon request, the school district will provide you with information regarding the following:

- Whether your child's teacher has met Georgia's state qualification and licensing requirements for the grade level and subject area in which the teacher provides instruction.
- Whether your child's teacher is teaching under emergency or other provisional status through which Georgia qualification or licensing requirements have been waived.
- Whether your child's teacher is teaching in the field of discipline of the certification held by the teacher.
- Whether your child receives services from a paraprofessional and, if so, the qualifications of the paraprofessional.

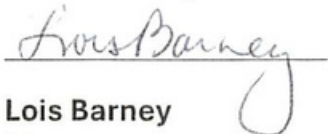

Si lo solicita, el distrito escolar le proporcionará información sobre:

- Si el maestro(a) ha cumplido con los requisitos de certificación y licencia establecidos por el Estado de Georgia para el nivel de grado y la materia que imparte.
- Si el maestro(a) está enseñando bajo un certificado provisional, temporal o de emergencia, mediante el cual se han eximido los requisitos estatales de certificación o licencia.
- Si el maestro(a) está enseñando en el área de la disciplina para la cual está certificado(a).
- Si su hijo(a) recibe servicios de un paraprofesional y, de ser así, cuáles son las calificaciones profesionales de esa persona.
