Closing and Delayed Opening Guidelines

In the case of inclement weather, (or other unforeseen emergencies) the Roslyn School District will exercise good judgment to determine whether schools will transition to remote instruction or a full closure. The information below details the school district's approach to school closings, delays, remote instruction and early dismissals.

SCHOOLS CLOSED

The first snow day of the school year will most likely result in a complete shutdown of the district, as we believe it's important to continue the tradition of a snow day. No after-school activities will occur on days when schools are closed. The decision to cancel school may occur the night before a storm, or in the early morning, based on the weather forecast.

DELAYED OPENING (Two-Hour Delay)

The district may determine that school can open with a two-hour delay, based on road conditions. (see chart below for delayed start times). Students who use school bus transportation should be at their assigned bus stop two hours later than normal. Students who walk should plan to arrive at their school two hours later than the normal arrival time. Students will be dismissed at their regular dismissal time at the end of the day.

EMERGENCY EARLY DISMISSAL

Dismissal time is determined based on inclement weather or unforeseen emergencies and is communicated to families as soon as possible.

DELAYED REMOTE OPENING (Two-Hour Delay)

The district will go remote with a two-hour delayed opening, as long as the area isn't experiencing a loss of power (see chart for two-hour delayed start times). Remote days allow us to preserve the school year calendar as planned, but the calendar is always subject to change in case of emergency.

SNOW CLOSING NOTIFICATIONS

Roslyn School District will send notifications to all staff and parents/guardians regarding school closings and delays via email, text, phone, and our ParentSquare app. Every school district family is automatically signed up to receive these notifications via our Powerschool platform. It is very important that families keep their information current in the system. To verify or update your information go to <https://sis.roslynschools.org/public/>

- Website - A pop-up notification will appear on the Roslyn School District website, notifying the school community of any school closings or delays.
- Local Media - Snow closings and delays are communicated to local media including: News 12 Long Island.

SCOPE Unscheduled Emergency Closing Policies & Procedures

- If the school district announces an emergency school closing, the SCOPE Child Care Program will be CLOSED.
- If the school district announces an unscheduled emergency early dismissal the SCOPE After School program may be cancelled or close early.
- If the school district announces a cancellation of after-school activities, the SCOPE After School Program may be cancelled or close early.
- SCOPE will activate a Connect Ed message to each parent/guardian home, work and cell phone numbers with information on the status of the program. It is the parent/guardian responsibility to make necessary arrangements in the event SCOPE is cancelled.

Stay Connected with ParentSquare

Roslyn School District is pleased to offer ParentSquare as our primary platform for school communication. Families receive messages through email, app, voice, or text, helping everyone stay informed and involved. An account is automatically created for each parent or guardian using the contact information in our student information system. We encourage you to activate your account to download the free mobile app, set your language preferences, and choose how and when you'd like to receive messages.

WHAT YOU CAN DO WITH PARENTSQUARE

- Receive updates from your school via email, app, or text notification
- Choose to get posts as they're shared or bundled in a daily digest
- View posts, photos, calendars, and important announcements
- Communicate in your preferred language with automatic translation*

*You can use ParentSquare to communicate in your native language. If you speak a language other than English, you can change your language settings so that you receive information in your preferred language.

FREQUENTLY ASKED QUESTIONS

What if my contact information is incorrect, or needs to be updated?

Please update your information in the PowerSchool Parent Portal. If you need further assistance, please contact the main office of the school your child attends.

How do I receive text messages?

ParentSquare will automatically send text messages to cell phone numbers. Be sure to keep your contact information updated through the PowerSchool Parent Portal.

What if I can't find the invitation from ParentSquare in my email?

Download the app using the links or QR code (on left) or go to www.parentsquare.com/signin and enter your email or cell phone number that is on file with the district to receive a new invitation link.

How do I limit the amount of notifications I receive throughout the day?

ParentSquare gives users the ability to receive all non-urgent messages in one notification that is sent daily at 6 p.m. This is called the "digest" setting. With the digest setting, you won't miss any important messages and you won't receive messages throughout the day. If you prefer to receive messages and posts throughout the day, you can choose the "instant" setting. With this setting, you will receive notifications in real time.

To access your notification settings from the computer, sign in at parentsquare.com/signin. In the top right corner, click on your name and select "My Account." Then, select "Notification Settings" on the left-hand side. For each site you're associated with, set your notification preferences for email, text, and the app.

To access your notification settings from the app, sign into the app, and click the three horizontal lines in the top left corner. Then, select "Account" followed by "Notifications." If you'd like to customize your settings for each site you're associated with, you can toggle on "Custom Settings." In the notifications screen, you can toggle on "App Notifications." You can choose between instant and digest for email and text, or you can toggle email or text notifications off.

Will I still receive messages from the district if I don't download the ParentSquare App?

Yes. The app is not required for you to receive district communication via email, text, or voicemail.

Balancing the use of Technology in our Schools

The Roslyn School District implements the statewide mandate (from the New York State Governor and the NYS Department of Education) that requires all districts to adopt clear guidelines around the use of personal electronic devices—such as cell phones and smartwatches—during the school day. In alignment with this directive, a committee of educators, staff, students, and parents came together to design guidelines focused on reducing distractions, improving academic engagement, and supporting students' mental health and well-being. To support meaningful learning and promote a balanced approach to technology, Chromebooks will be used purposefully to enhance instruction and support student learning. Teachers will prioritize live, interactive instruction where students actively engage in dynamic discussions that foster genuine connections and sense of community.

These guidelines build on existing K-8 expectations and extends them to include our high school community. Students will be expected to turn off and store their devices during the school day unless explicitly permitted for educational or support-related reasons. This helps to create an environment where students can be more present, connected, and focused. We encourage all families to review the FAQ below, and to reach out to their school's leadership with any questions. Your partnership is key to making this a success.

Teaching in a Digital World; Finding Balance: FAQ for Families

1. What devices are included in this mandate?

We are limiting the use of cell phones, smartwatches, and mobile hotspots (unless authorized for schoolwork) during the school day so students can fully engage with each other and their learning. These devices must be turned off and stored during the school day, unless explicitly permitted by a teacher, principal, or the District for educational or individual support reasons. At the high school only: Personal laptops, iPads and school-issued tablets can still be used for learning. iMessage and social media apps must be turned off.

2. Are there any exceptions? Yes. Device use may be permitted for:

- Medical needs
- IEPs or 504 Plans
- Teacher-directed academic activities
- Translation tools
- Caregiving responsibilities (approved case by case)
- Emergencies

3. When does the mandate apply?

This is a "bell-to-bell" mandate. It begins at the start of the school day and extends to the final dismissal bell. This includes classroom time, lunch, and hallway transitions.

4. What about after-school activities, sports, and clubs?

The mandate applies only during the instructional school day. Once the final dismissal bell rings, students may use their personal devices. Coaches and advisors may still set rules specific to their activity.

5. How will this look at each school?

Elementary Schools: Devices must be turned off and placed in backpacks or stored in designated classroom areas from the beginning of the school day until the end of the school day.

Secondary Schools: Devices must be turned off and stored in lockers or in secured classroom spaces from arrival until dismissal, unless explicitly permitted for educational or individual support reasons.

6. How can I contact my child during the day?

7. How can my child reach me?

Elementary: Students may use the main office phone, nurse's office phone or another supervised phone with staff permission.

Secondary: Middle school students can access a designated phone in the main office, guidance office and/or nurse's office. High school students can access designated phones in the main office, counseling center, and/or nurse's office.

8. What happens if a student violates this mandate?

Students may be penalized for violating the New York State mandate.

Consequences may include:

- A warning to put device away
- Confiscation of the device, which will be brought to the main office until the end of the school day
- Confiscation of the device, which will be brought to the main office until the end of the school day when a parent/guardian may pick it up
- Detention

Parent & Community Notifications

FAMILY EDUCATIONAL RIGHTS AND PRIVACY ACT (FERPA)

Under the Family Educational Rights and Privacy Act (1974) (FERPA), parents/guardians of a student under 18, or eligible students age 18 or older, have a right to:

- inspect and review the student's education records within 45 days of the day the district receives a request for access. Parents or eligible students should submit to the building principal a written request that identifies the records they wish to inspect.
- request the amendment of the student's education records that the parent or eligible student believes are inaccurate or misleading.
- consent to disclosures of personally identifiable information contained in the student's education records, except to the extent that FERPA authorizes disclosure without consent (e.g., disclosure to school officials with legitimate educational interests).
- file a complaint with the U.S. Department of Education concerning alleged failures by the district to comply with the requirements of FERPA.

In addition to the rights outlined above, FERPA also provides that a school district may designate certain student information as "directory information", which is information that is generally not considered harmful or an invasion of privacy if released. Directory information includes a student's name, award recognitions, photograph, weight and height if a member of an athletic team, and participation in officially recognized activities and sports. Further, directory information will only be made available to parent/faculty associations, representatives of the District's insurance carriers, entities providing educational, occupational, or career opportunities, or to publish in school news publications, school student newspapers, magazines, yearbooks or other student publications, daily or weekly newspapers for journalistic purposes only, athletic, musical or theatrical programs, or news releases.

The School District may disclose "directory information" without prior consent if it has given public notice to parents of students in attendance and eligible students in attendance in the School District of: the type of personally identifiable information that has been designated as directory information; the parent's or eligible student's right to refuse disclosure of certain or all designated information; and the period of time the parent or eligible student has to notify the School District in writing that he/she wishes to withhold consent for disclosure.

Requests to view or amend a student's records, or to withhold consent for disclosure of personally identifiable information, may be addressed to the building principal.

Requests to withhold consent for disclosure of directory information must be submitted in writing and returned to the building principal by September 15 each school year, or in the case of new students who enter school during the school year, within 15 days of entry.

STUDENT PRIVACY

Under the Protection of Pupil Rights Amendment, as revised by the Every Student Succeeds Act, parents may contact the building principal to opt a child out of the following activities:

- The collection, disclosure and use of personal information gathered from students for the purpose of marketing or selling that information. This does not apply to the collection, disclosure, or use of personal information collected from students for the exclusive purpose of developing, evaluating or providing educational products or services for or to students.
- The administration of any survey revealing certain types of personal behavior or political beliefs.
- The administration of any invasive physical examination or screening that is not necessary to protect the immediate health or safety of the student or other students. This does not apply to any physical examination or screening required or permitted under state law, including those permitted without parental notification.

Parents may also request that their children not appear in photographs that are used for purposes of general publicity, either on line or in print. Contact the school principal.

DISCLOSURE TO THE MILITARY

Pursuant to the Every Student Succeeds Act, the school district must disclose to military recruiters and institutions of higher learning, upon request, the names, addresses and telephone numbers of high school students. Parents (or students 18 years of age or older) wishing to exercise their option to withhold their consent to the release of the above information to military recruiters and/or institutions of higher learning must make such request in writing to the high school principal.

DIGNITY FOR ALL STUDENTS ACT (DASA)

DASA, or the Dignity for All Students Act, is a New York State law designed to protect students from discrimination, harassment, and bullying in schools. It promotes a safe and supportive learning environment where every student is treated with respect and dignity.

FREEDOM OF INFORMATION LAW

Transportation

DISTRICT BUS SERVICE

Bus service is provided within the district for all public, private and parochial school students K-8, regardless of the distance between their home and school, provided it is less than 15 miles. It is also provided to high school students in grades 9-12 who live more than 1/2 mile but less than 15 miles from school. Limits are strictly enforced and drivers are instructed to deny transportation to those who do not qualify. Late buses are available for Roslyn School District students participating in after-school activities. State law provides that students attending private or parochial schools outside the district are entitled to busing at district expense upon application by parent/guardian.

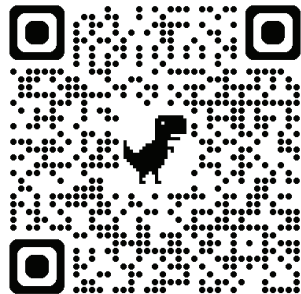
PRIVATE & PAROCHIAL SCHOOL TRANSPORTATION

In accordance with New York State Education Law and Board of Education policy, all requests for transportation of children in the Roslyn School District to private and parochial schools, as well as before and/or after school child care locations for the school year, must be submitted in writing by a parent, guardian or authorized representative by April 1.

Parents whose children currently receive transportation to private and parochial schools must submit a new request each year along with proof of residency. Failure to meet the April 1 deadline may result in the loss of transportation services.

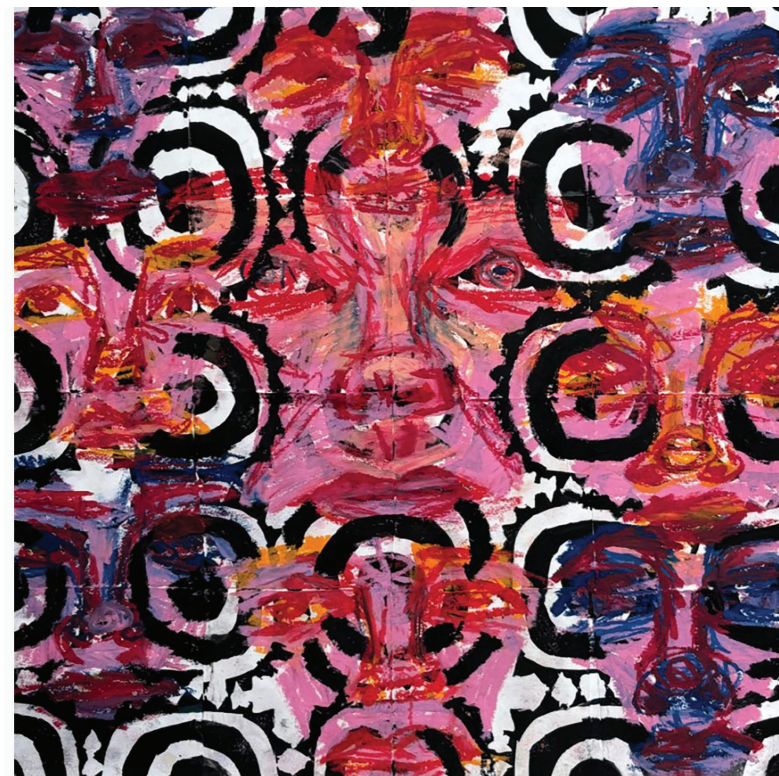
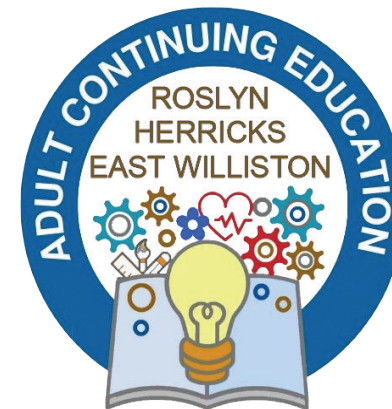

Voter Information

VOTER REGISTRATION

In order to vote you must be a U.S. citizen, 18 years old or older, and a resident of this school district for at least 30 days before the vote. In addition, a resident must be registered either with the school district or with the Nassau County Board of Elections. If you have not voted in a district or general election in the last four years, or are a new resident and have not registered to vote either with the school district or the Board of Elections, you need to register in advance to be able to vote in the school budget vote and election.

EARLY VOTER APPLICATION

You are eligible to vote by Early Mail Voter Ballot if you are a qualified voter.

A qualified voter is:

- A citizen of the United States
- At least 18 years of age; and
- A resident of the school district for a period of at least 30 days preceding the meeting or election at which you seek to vote.

Applications may not be transmitted electronically because an original signature is required. Upon receipt, your application will be reviewed, pursuant to the provisions of the Education Law, to establish your entitlement to vote by Absentee Ballot. A ballot will then be issued to you.

Please note, you will not be eligible to vote by Absentee Ballot if:

- Your application is incomplete, unsigned or undated,
- You are not a qualified voter of the Roslyn School District, or
- You will be unable to vote in person for the Budget Vote & Trustee election in May, for a reason other than those provided for on the application form.

Roslyn Summer Academy

The Roslyn Summer Academy is a four-week program designed to extend learning opportunities for Roslyn School District residents who have completed any grade from Kindergarten through Grade 8. The daily four-hour program targets instruction in English Language Arts and Mathematics through project-based learning and thematic units of study. Students will extend their learning through engaging activities and multiple field trips.



The program is staffed by certified Roslyn School District teachers, a school nurse, and a Roslyn administrator. Instruction focuses on skill development in English Language Arts and Mathematics. The core curriculum includes early literacy competencies and mathematical concepts in Grades K-3 and grade-specific literacy and mathematical skills in Grades 4-8. Children participate in reading, writing, listening, technology, and mathematical activities.
