As a valued member of our school community, your involvement as a chaperone is greatly appreciated. **To ensure the ongoing safety and well-being of our students, we are updating our current Field Trip/School-Sponsored Activity requirements for all interested parents/guardians/chaperones.** Please see below for details:

- ALL parents/guardians/chaperones planning to attend field trips or school-sponsored activities must obtain a background check ANNUALLY from either the Family Care Safety Registry or through the Missouri State Highway Patrol (Missouri Automated Criminal History Site – MACHS) Name Search Portal.
- Background checks must be dated August 1 – September 30 of the current school year.
- Background checks must be submitted to the school via paper copy or electronic copy **by September 30** of the current school year.

Background check through the Family Care Safety Registry (FCSR):

- For NEW registrants, online registration is available for a non-reimbursable, total cost of \$15.55. **You will need:** Internet access, social security number, e-mail address, and a credit/debit card. <https://health.mo.gov/safety/fcsr/>
- For PREVIOUS registrants, you must call the FCSR and request an updated report (no fee). **You will need:** Social security number and e-mail address. They will verify your address and send an updated report via e-mail. Phone: 866-422-6872 or 573-526-1974.

Background check through MACHS Name Search Portal:

- For NEW registrants, online registration is available for a non-reimbursable \$15.00 plus processing fee. You must create an account. Once the background check is complete, please submit a printed or electronic copy to the District. **You will need:** Internet access, social security number, date of birth, and a credit/debit card. <https://www.machs.mo.gov/MocchWebInterface/home.html>
- For PREVIOUS registrants: Contact the District Office during the listed timeframe to request an updated records check.

Additional information:

- The District is not responsible for transportation to or from the activity for any parent/guardian/chaperone.
- Parents/guardians/chaperones must purchase their own entry/event tickets. If this option is not available due to event guidelines, the District will share pertinent information prior to the activity, and make arrangements.
- Each student is allowed two (2) parents/guardians/chaperones per trip. No siblings will be permitted to attend.
- Attendance will be effected for those students signed out from the activity by parents/guardians/chaperones.
