The following questions have been asked by Dealers/Vendors and answered by Community ISD.

NO. 1. - QUESTION #1

Is this an all or none bid submission?

Answer : Partial bids across the schedule of items are acceptable; bidders are not required to quote all line items. However, bidders must provide a complete proposal for each line item they elect to bid. Awards may be made by line item, but partial offers for a single line item will be deemed non-responsive.

NO. 2. - QUESTION #2

Is the building just one level?

Answer: Not entirely. However, all areas included in the scope of work for this furniture package are located on one level directly accessible from the ground level.

NO. 3. - QUESTION #3

Is there any existing furniture to be relocated here?

Answer: No. There is no existing furniture to be relocated as part of this project. All furniture included in the scope of work is new.

NO. 4. - QUESTION #4

Are we limited to the 5 Page submission?

Answer: Yes. The proposal narrative is limited to a maximum of five (5) pages and should address the evaluation criteria outlined in the solicitation, including firm experience, personnel qualifications, applicable resources, and project approach. The required Excel pricing workbook must be submitted with the proposal; however, it is not counted toward the five-page limit.

NO. 5. - QUESTION #5

Does the HS or MS have a dock?

Answer: Neither the High School nor the Middle School has an elevated loading dock. Vendors should plan deliveries accordingly and assume ground-level access at both locations.

Community Leland Edge Middle School construction will be done in one phase. This will require one delivery and installation schedule. Furniture will need to be priced for one order. Refer to the attached drawings for furniture plans, master list, and room by room lists. Furniture for the additions and renovations will have a target delivery week of **July 13th, 2027**.

Furniture will be located on one level. Staging areas will be available. Coordinate with Pogue Construction for space and flooring protection. Jobsite work hours will be managed by CMaR Pogue Construction.

3. PERIOD OF AGREEMENT

The Term of this agreement will become effective after formal approval by the CISD Board of Trustees.

4. PRICING

Pricing and a detailed list of all items included in the pricing must be provided in addition to the proposal.

Pricing must include:

- Line items of all furniture including quantity, unit cost, total cost
- All listed items must be priced; if you can't provide pricing for item clearly identify that you are not bidding that item; if an alternate is proposed it must be clearly designated (alternates must include description, part number, manufacturer)
- Delivery Charges to be a separate line item
- Installation Charges to be a separate line item
- Any temporary storage costs (as needed)
- Pricing must be submitted in an MS Excel format. Please see attached Excel template for format reference. Dealer/Vendor is expected to use the attached Excel template with the pricing shown.

5. PROPOSAL (maximum 5 pages)

Proposals should be submitted with descriptions of your firm's services.

6. EVALUATION OF BIDS

This proposal will be awarded in the best interest of the District. Final evaluation of this proposal will be based on the Texas Education Code 44.031(b). The following considerations shall be taken into account to determine the best value for the district.

7. AWARD

CISD may award this contract to multiple or a single dealer/vendor, in order to best serve the needs of the District. All dealers/vendors properly responding on time to this proposal will be considered for award. Dealer/s will be notified of award. The dealer/s who is awarded this contract will be identified as an “approved vendor” for CISD.

8. **ESTIMATED ANNUAL EXPENDITURE:**

Community ISD does not guarantee the volume (quantity or dollar value) to be purchased annually and purchases may be made from any awarded vendor. The actual dollar amount to be purchased depends on the actual needs of the District, and budgetary constraints.

9. **RESPONSE FIELDS**

All required fields must be completed to comply with State of Texas bid laws. Proposals must be submitted using the forms mentioned in the format provided and using the specified pricing references.

13. PURCHASE ORDER

All purchases against this contract will be authorized through the use of a Community ISD purchase order. **Orders must not be fulfilled (shipped and or delivered) without a Community ISD authorized purchase order.** The Owner will provide the Excel template to be used for the final quote submission. Quantities are to be summarized by total item quantity and should not be presented separately by room.

All invoices and packing slips from successful vendor must include the CISD purchase order number, manufacturer's identification number and discounted price of items and/or services as stated in this agreement.

14. DEVIATIONS

Any deviation to the Standard Terms and Conditions of this proposal request must be clearly stated in writing in the Deviation Compliance field.

15. CANCELLATION

CISD reserves the right to cancel this contract should any of the following occur:

- the vendor(s) proceeds in a manner that does not comply with the contract
- should services or quality of the goods become unacceptable as determined solely by CISD
- the vendor(s) does not carry out the provisions of this contract in its true intent and meaning as indicated in the scope of work.

Prior to contract cancellation, the dealer/vendor(s) will be served with written notice to provide satisfactory compliance with the contract without penalty. If the vendor neglects or refuses to follow such notice within thirty (30) days CISD may cancel the contract.

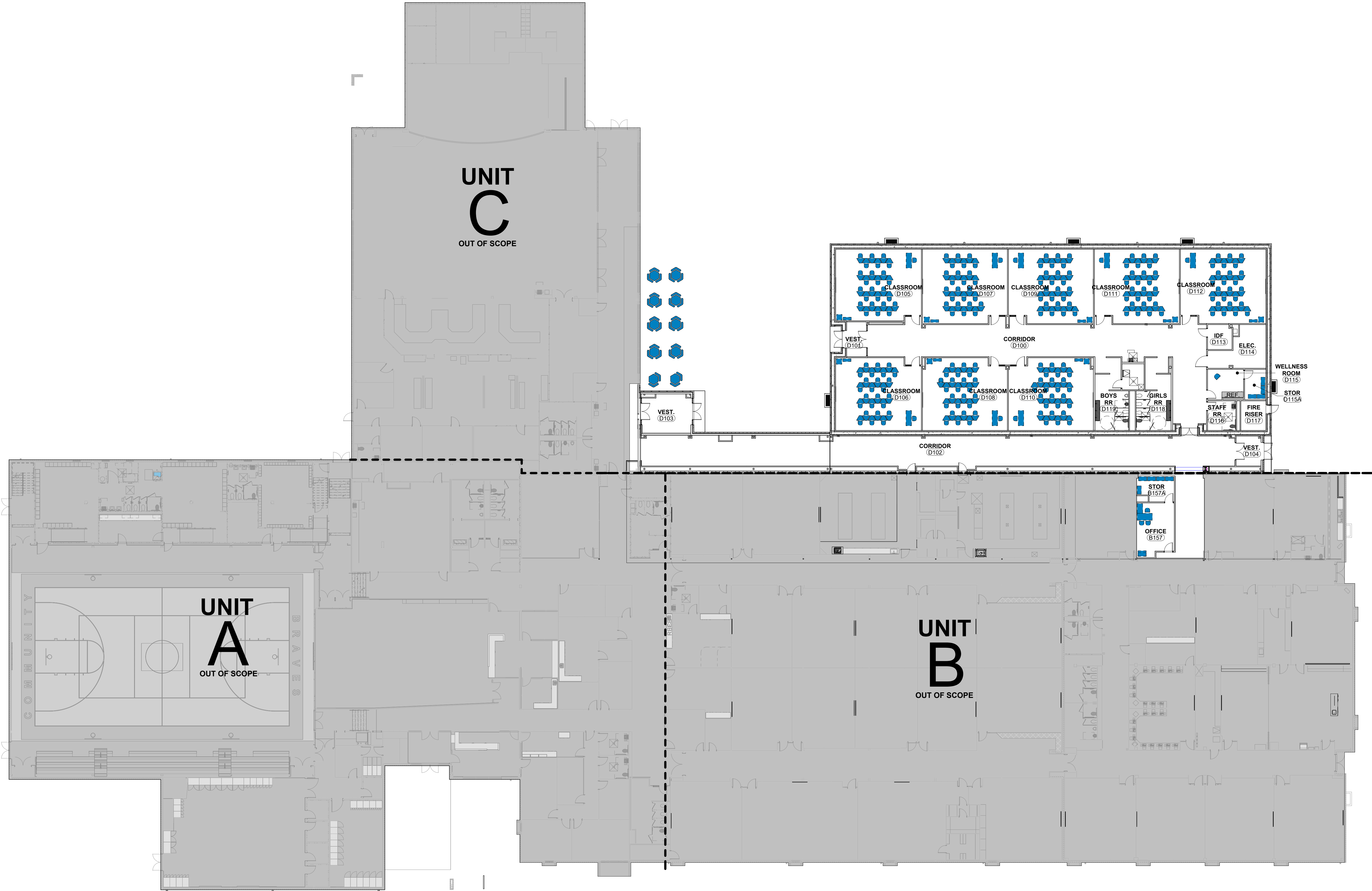

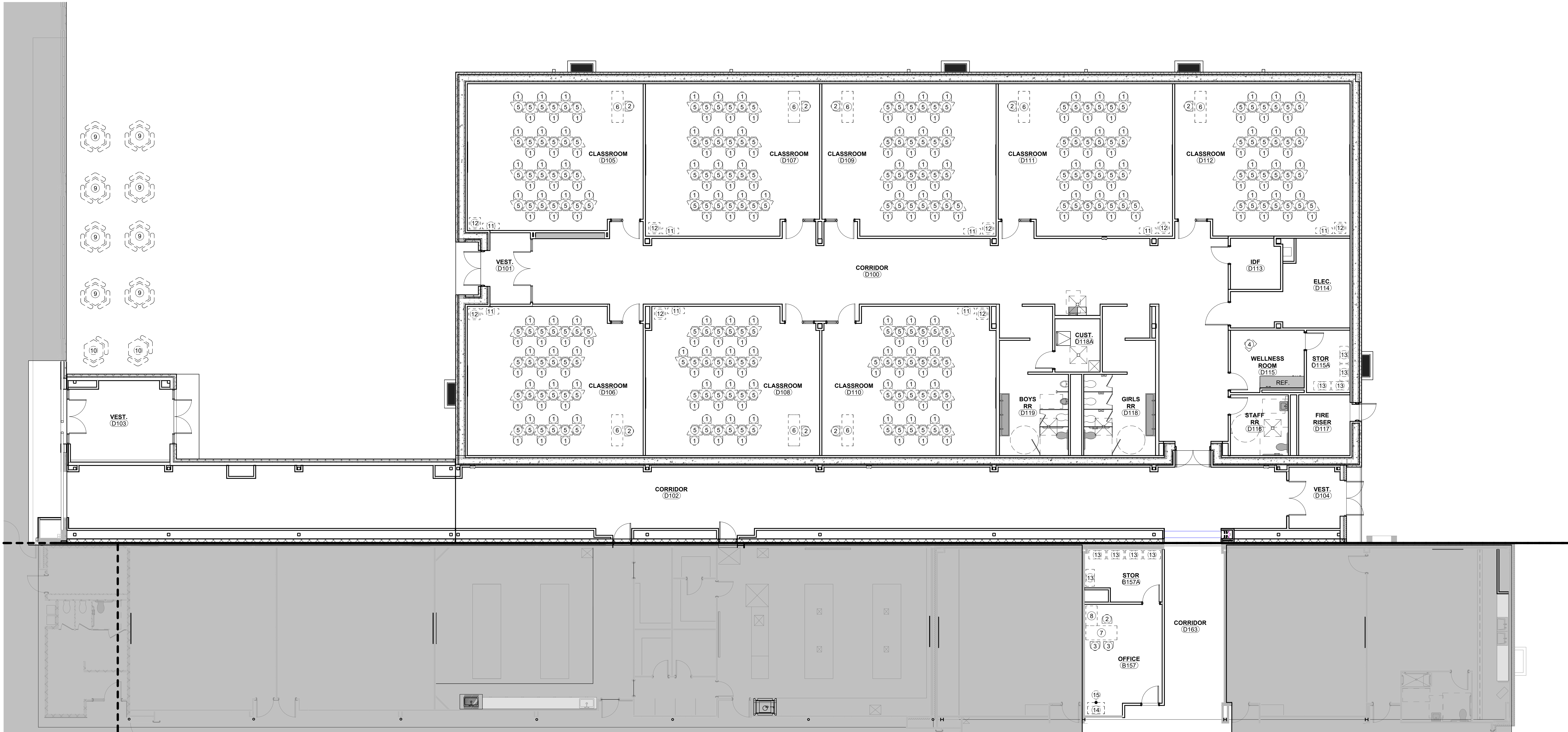
