Parental involvement means the participation of parents and or family in regular, two-way and meaningful communication involving student academic learning and other school activities, including ensuring:

San Benito High School shall convene an annual Title I meeting. Section 1116 (c) (1)

Title I meeting will be held more than once a school year. The meeting will be at flexible times. Parents/family and community will be notified online on the district and school web page and social media. At the annual meeting parents will be notified of State Assessments results and school report card.

San Benito High School shall offer a flexible schedule of meetings, such as meetings in the morning or evening, and may provide, with funds provided under this part, transportation, or home visits, as such services relate to parental involvement; Section 1116 (c)(2)

San Benito High School shall involve parents, in an organized, ongoing, and timely way, in the planning, review, and improvement of programs, Parent and Family Engagement Policy and development of Campus Improvement Plan. (participation of parents/family) Section 1116(c)

San Benito High School shall provide parents/family information of participating children

- Timely information about programs under this part
- A description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and

- the achievement levels of the challenging State academic standards
- If requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children and respond to any such suggestions as soon as practicably possible; section 1116 (c)(4)

San Benito High School will:

Provide high-quality curriculum and instruction in a supportive and effective learning environment that enables the participating children to meet Texas student academic achievement standards as follows: section 1116 (e)

- Provide high quality curriculum and instruction by focusing on implementing the district curriculum through TEKS resource, textbooks, online resources and use of technology.
- Parent/Teacher conferences are available to inform parents about student's performances. Teachers are available before, after school or during conference period. Teachers will reach out to parents via phone, email, and mailed letters.
- Provide parents progress reports every three weeks, and report cards every nine weeks on SKYWARD Parent Portal
