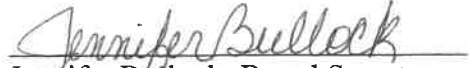
President Kamus announced the Regular August Meeting, Wednesday, August 12, 2026 at 7:00 p.m. at the Middle School.
