ASPIRE ACADEMY HIGH SCHOOL

Seniors may have open campus only on the final day of each week with written parent permission. One additional day may be permitted at principal discretion.

DOUGLAS HIGH SCHOOL

Closed Campus for Grades 9-10 Juniors & Seniors (in good standing) may have open campus daily at the principal's discretion and with written parent permission.

GEORGE WHITTELL HIGH SCHOOL

Closed Campus for Grades 7-10 Juniors & Seniors (in good standing) may have open campus daily at the principal's discretion and with written parent permission.

Off-campus lunch is a privilege for students in good standing or any other criteria as established by the school administration. Guidelines for this privilege are:

- Students must be on track to graduate
- Students must not be failing any classes
- Students must not be tardy to the class following lunch
- Students must not attempt to sneak out other students who do not meet the requirements of this privilege
