The work session was called to order/Instruction for Public Comments: President Warren at 6:05 p.m.

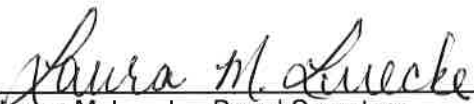
