- Follow all NLHS School rules, policies and procedures.
- Be **at least** a Freshman in High School **and** no older than 20 years of age.
- Both the Northern Lehigh student and his/her Guest must have this registration form completed in its entirety.
- This form must be signed by the guest's high school administrator.
- Guests must be recommended by an administrator from their high school, college or their immediate supervisor if not currently enrolled in school.
- If the guest is in the military, their immediate supervisor must give his/her recommendation.
- Not presently be suspended or expelled from any school and be in good standing at his/her high school to attend.
- **Forms must be submitted either in person or by email, to the Main Office of NLHS by 2p.m. on (Date must be 2 weeks prior)**
- **NO UNREGISTERED GUESTS WILL BE ADMITTED ON THE NIGHT OF THE PROM. NO EXCEPTIONS!!!!!!**
- Guests must follow all rules and guidelines for NLHS as stated in the NLHS Student/Parent Handbook. Students and/or guests are not allowed to leave the prom and return later – **NO EXCEPTIONS!!**
