REGULATIONS

1. *All student-driven vehicles must be registered and must display a sticker indicating their assigned spot number on the back of the rearview mirror. Lack of a permit will result in revocation of student privileges and/or school discipline.*
2. *Students must park in **assigned** spaces on the lots between the middle school, high school, and at the field hockey field, or in assigned spots at the football field. Students **MAY NOT** park in any area designated with yellow lines, visitor's spaces, handicapped spaces, or behind the high school by the tennis court. Failure to follow this policy will result in disciplinary action.*
3. *Students must obey school regulations and all the laws of the Commonwealth of Pennsylvania. The speed limit on school grounds is 10 M.P.H. Students are not to park in the fire zones, bus loading zones, and/or adjacent to any yellow curb.*
4. *Students who drive to school, (whether they are the driver or passenger), must follow the school's arrival procedures. (i.e. - arrival to homeroom on time.)*
5. *Students are not permitted to allow other students to park in their spots for any reason including the following: A) another student is driving you to school in their car, B) you will be absent, and your spot will be empty. Failure to adhere to this will result in disciplinary action.*
6. *Use or possession of tobacco, alcohol, or controlled substances is prohibited on school grounds.*
7. *Sitting or riding on hoods, roofs, or open truck beds of vehicles is prohibited and will result in loss of driving privileges..*
8. *The Northern Lehigh School District is not responsible for accidents or vandalism, which occur on the school property. Any accident is the responsibility of the parties involved. Vandalism will be reported to legal authorities. Persons at fault in accidents or vandalism may have driving privileges revoked.*
9. *Infractions of parking regulations and/or driving regulations may result in notification to police authorities and parking privileges may be revoked.*
10. *Students are reminded that cars are subject to searches where reasonable suspicion or probable cause exists that the vehicle may contain tobacco, drugs, alcohol, and/or weapons.*
