Criminal Offender Record Information (CORI) and Sex Offender Registry Information (SORI) Acknowledgement and Authorization Form

Nantucket Public Schools is registered under the provisions of M.G.L. c. 6, § 172 to receive CORI for the purpose of screening current and otherwise qualified prospective employees, subcontractors, and volunteers.

In order for prospective employees, subcontractors, volunteers or staff members to be eligible to participate in an academic or community program that involves potential unsupervised contact with children, or the disabled, the applicant may be required to undergo a Criminal Offender Record Information (CORI) check and/or a Sex Offender Registry Information (SORI) check. Any applicant found to have certain criminal convictions or pending criminal actions will be presumed ineligible to participate in such activities. The Nantucket Public Schools is authorized by the Commonwealth's Department of Criminal Justice Information Services, pursuant to Massachusetts General Laws, Chapter 6, Sections 167-178B, to access CORI records. Sex Offender checks shall be performed pursuant to Massachusetts General Laws, Chapter 6, Sections 178C-178P. The Nantucket Public School's assessment of CORI records is based on regulations issued by the Executive Office of Health and Human Services, 101 Code of Massachusetts Regulations 15.00-15.17. SORI checks are performed pursuant to Massachusetts General Laws, Chapter 6, Section 178C-178P.
