Student MiniMester Contract

2027

MiniMester is designed to offer opportunities for students to travel and serve others locally, nationally, and internationally. These experiences promote Christ-like servant leadership and encourage individuals to share the love of God while being the hands and feet of Jesus.

The following requirements and expectations will apply for all MiniMester trips:

1. Students must be in good academic standing. Any student failing two or more classes at the end of the first semester will be removed from the trip and **all monies are non-refundable**. If booked through a 3rd party, the company's refund policy will supersede the Strong Rock Christian School policy.
2. All student accounts, including FACTS tuition, Athletics, and Fine Arts must be current. Students with delinquent accounts will be removed from the trip and **all monies are non-refundable**.
3. Student behavior in the classroom or while participating in any organization or activity that represents Strong Rock Christian School on or off campus should reflect the guidelines in the Strong Rock Family Handbook. Students receiving ISS 2nd semester will meet with the principal to discuss the consequences of participation on a MiniMester/Class trip or paid activity. Students receiving OSS 2nd semester will not be allowed to attend MiniMester/Class trip. If a student is not allowed to participate on a MiniMester team for any reason, **all monies are non-refundable and non-transferrable**, and the student will be assigned to the provided rotation classes during the week.
4. While serving on the MiniMester trip, inappropriate behavior can be grounds for the student to be sent home at the expense of the parents. Student is subject to discipline upon return.
5. If Strong Rock Christian School cancels a MiniMester trip after the initial deposit, payments can be refunded or transferred to another trip upon approval of the Team Lead. If booked through a 3rd party, the company's refund policy will supersede the Strong Rock Christian School policy.
6. Once a student is officially accepted on a MiniMester team, if the student/family decides not to participate in the trip, the entire balance of the trip will be due or applied to your FACTS tuition account, and all monies are **non-refundable and non-transferrable**.
7. Payments:
 - a. No Cash or check will be accepted. Payment will be accepted ONLINE ONLY.

 - c. Unless otherwise designated, **all trip balances must be paid in full by March 2nd in order to participate in a trip.**
 - d. Any unpaid MiniMester balance to Strong Rock or any 3rd party entity must be paid in full prior to travel.
 - e. Any unpaid balances will prohibit a student from re-enrolling for the next school year.
8. Parent Led trips will not be approved.

Thank you for prayerfully considering participation on a MiniMester Mission Team/Trip and we believe that God will direct you to the trip that He has prepared for you.
