DESIGNATED PERSON ASSURANCES

In accordance with 40 CFR 763.93(i) of the Environmental Protection Agency Asbestos-Containing Material (ACM) in Schools regulation, the undersigned Designated Person (DP) hereby certifies that the following general responsibilities under 40 CFR 763.84 have been or will be met:

1. Complete adequate training to perform AHERA Designated Person duties.
2. Ensure that all custodian and maintenance employees receive 2-hour asbestos awareness training within 60 days of hire and at least once every year after as refresher.
3. Ensure the Asbestos Management Plan is properly maintained and available at the school for inspection.
4. Ensure that all staff, parents, students, and other building occupants are informed at least once each school year about inspections, abatement and response actions, surveillance activities, as well as the availability of the Asbestos Management Plan.
5. Ensure that contractors and short-term workers who may come in contact with asbestos in the school are provided information regarding the locations for Asbestos-Containing Materials (ACM) before they begin work in the school.
6. Ensure Six-Month Surveillance is conducted and recorded at least once every six-month period by the Designated Person or another staff member who is appropriately trained in asbestos awareness.
7. Ensure that all warning labels are posted.

ANNUAL ASBESTOS MANAGEMENT PLAN NOTIFICATION NOTICE OF AVAILABILITY

To Staff, Parents/Guardians, and Students:

This notice serves to fulfill annual notification requirements in accordance with Section 763.93 of the *Asbestos Emergency Response Act* (AHERA). AHERA requires that all school buildings be visually inspected by accredited inspectors to identify all asbestos-containing building materials (ACBM) that may be present in the school environment. As required under AHERA, **Ahfachkee Day School** must maintain an Asbestos Management Plan (AMP) and keep the AMP on file at the school, and the School Administrative Office. The AMP is available for review during school hours, Monday through Friday, in the front office

An AHERA certified inspector determined no Asbestos Containing Building Material (ACBM) are present and the architect/project engineers responsible for the construction of our school facilities certified in a written statement that no ACBM was used as a building material in the buildings.
