

**RESOLUTION OF THE BOARD OF TRUSTEES OF THE
CASTLEBERRY INDEPENDENT SCHOOL DISTRICT**

On this date, we, the Board of Trustees of the Castleberry Independent School District hereby levy or set the tax rate on \$100 valuation for the District for the tax year 2026 at a total tax rate of **\$1.24690/\$100**, to be assessed and collected by the duly specified assessor and collector as follows:

\$0.74690/\$100 for the purpose of maintenance and operations, and

\$0.50000/\$100 for the purpose of payment of principal and interest on debts.

Such taxes are to be assessed and collected by the tax officials designated by the District.

**THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND
OPERATIONS THAN LAST YEAR'S TAX RATE.**
