DIESEL FOR COUNTY SCHOOL BUSES. All Diesel must be on road Diesel Fuel. Locations to be delivered to are **Bus Shop, Belgreen School, East Franklin School, Phil Campbell School, Red Bay School, and Vina School.**

You are invited to bid on approximately 30,000 (+/-) gallons of on road Diesel Fuel, to be delivered as needed to the above-mentioned locations. (Tanks will also need to be furnished) The Distributor will have the right to increase or decrease the price of the gasoline or diesel **upon furnishing to the Board of Education a copy of notice from the supplier denoting such change.** This bid will include all diesel used from these tanks by the Franklin County Board of Education between the dates of **October 1, 2026 through September 30, 2027 to the above-named locations.**
