SWIMMING POOL – MIDDLE SCHOOL

Groups 1, 2	No Charge For Facility – Lifeguards Required

Group 4	\$150 per hour (plus lifeguards)
Group 5	\$225 per hour (plus lifeguards)

Actual cost for lifeguards will be charged to all groups, regardless of charge for facility.

SERVICES OF CUSTODIANS (when required by either school district or facility user)

When custodial services are required for event setup, monitoring, maintenance, or cleanup, Groups 4 and 5 will be charged the actual cost incurred by the District for those services. Groups 1, 2, and 3 will not be charged custodial fees for routine use of district facilities. Custodial fees may be assessed for tournaments or special events that require dedicated custodial staffing for setup, event support, and cleanup. Events requiring custodial services outside of normal work hours will be charged the District's actual cost for the additional staffing required.

YOUTH CAMPS –No facility use fees will be assessed for youth camps held for school district residents by Schuylkill Valley School District employed coaches as long as all associated coaches receive no salary compensation for working the camp. If said coaches receive a salary for working a youth camp, facility use fees will be assessed at the Group 3 rate for the camp.

TOURNAMENTS –No facility use fees will be assessed for tournaments held by Schuylkill Valley sports teams during PIAA regular season.
