- Board Policy 8210 School Calendar
Mr. Denny reviewed Board Policy 8210, School Calendar, which states that the Superintendent is authorized to develop and implement a plan for a virtual education delivery model in order to make up hours for calamity days. The virtual education delivery plan must be approved by the Board. Mr. Denny will present the plan for approval at the July 27, 2026 regular meeting.
- School Uniform Policy – 5511.01
Mr. Denny reviewed the school uniform policy. The policy will be presented to the Board at the July 27, 2027 regular meeting and will have no changes recommended at this time. The district will continue to study the policy for possible revisions.
- Overnight Field Trip Academic Eligibility Criteria
Mr. Denny and the Board reviewed the form “Proposal for Overnight/Extended Student Trips”. The discussion concerned the academic requirements for students who will be going on field trips.

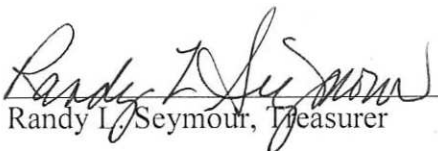
- Mr. Seymour informed the Board that the Ohio School Boards Capital Conference is November 15-17, 2026.
