SCHOOL-PARENT COMPACT

School Responsibilities

The Big Beaver Elementary School will:

- *Can be scheduled virtually at the request of parent/guardian and/or teacher*

- 3. Provide parents with frequent reports on their children's progress.**

Specifically, the school will provide reports as follows:

- *All reports will include most recent performance data*

Specifically, staff will be available for consultation with parents as follows:

- *Open House*
- *Meetings at the request of the parent (before, during and after school hours)*

- *Phone calls*
- *E-mail (through the district maintained website)*
- *Virtual (google meets, zoom, etc.)*

5. Provide parents opportunities to volunteer and reasonable participation in their child's class and activities, as follows:

- *Annual written invitation from staff to the parents*
- *Give opportunities for parents to learn new curriculum and strategies*

Additional Required School Responsibilities

The Big Beaver Elementary School will:

1. Involve parents in the planning, review, and improvement of the school's parental involvement policy, in an organized, ongoing, and timely way.
2. Involve parents in the joint development of any school-wide program plan, in an organized, ongoing, and timely way.
3. Hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements, and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a convenient time to parents, and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. Provide to parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet.

To help build and develop a partnership with parents to help their children achieve the State's high academic standards, the Big Beaver Elementary School will:

1. Recommend to the local educational agency (LEA), the names of parents of participating children of Title I, Part A programs who are interested in serving on the State's Committee of Practitioners and School Support Teams.
2. Notify parents of the school's participation in Early Reading First, Reading First and Even Start Family Literacy Programs operating within the school, the district and the contact information (as applicable).

Parent Responsibilities

- *By reviewing our child's daily homework folder each night; checking for any paper notices from the school.*
- *By checking school and classroom Class Dojo messages daily.*

- *By helping with/checking homework nightly and making sure that homework is completed to the best of our child's understanding.*
- *By making the classroom teacher aware of any particular concern, academic or otherwise, that we may have.*
- *By monitoring and limiting the amount of television/screen/video time of our child to no more than two hours daily as is recommended by the American Academy of Pediatrics.*
- *By maintaining healthy sleep habits, routines, and times for my child as is recommended by the American Academy of Sleep Medicine.*
- *By working to maintain a schedule of 9-12 hours of sleep per 24 hours for my child as is recommended by the American Academy of Sleep Medicine.*
- *By participating, as appropriate, in decisions relating to my children's education.*
- *By promoting positive use of our child's extracurricular time.*
- *By staying informed about our child's education and communicating with the school by promptly reading all notices from the school or the school district either received by our child or by mail and responding as appropriate.*
- *By working/volunteering/participating in PTO conducted activities*
- *By serving, to the extent possible, on policy advisory groups (i.e., such as being the TitleI, Part A parent representative on the school's School Improvement Team, the Title I Policy Advisory Committee, the District-Wide Policy Advisory Council, the State's Committee of Practitioners, the School Support Team, or other school advisory or policy groups).*

Student Responsibilities
