**Letter to Parents for School Meal Programs
Special Provision Options (Provision 2 Non-Base Year & Community Eligibility Provision)**

Dear Parent or Guardian:

We are pleased to inform you that Syosset Central School District will be offering meals at no cost to schools participating in the National School Lunch and School Breakfast Programs for 2026-2027.

What does this mean for your child(ren) attending the school(s) identified above?

All students enrolled at Syosset Central School District are eligible to receive a healthy breakfast and lunch at school at **no charge** to your household each day of the 2026-2027 school year. Your child(ren) will be able to participate in these meal programs without having to pay a fee or submitting an application. No further action is required of you.

Families are strongly encouraged to complete and submit the Household Income Eligibility Form as this form will determine eligibility for State and federal funding/programs that your child(ren) may qualify for if the household income falls at or below the limits on this chart:
