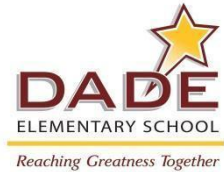

GENERAL EXPECTATIONS

Dade Elementary School agrees to implement the following policies:

- Dade Elementary School will jointly develop with parents and distribute to parents of participating children a Parental Involvement Policy that the school and parents of participating children agree on.
- Dade Elementary School will notify parents about the Parental Involvement Policy in an understandable and uniform format and, to the best of their ability, will distribute this policy to parents in a language the parents can understand.
- Dade Elementary School will make the Parental Involvement Policy available to the local community.
- Dade Elementary School will periodically update the Parental Involvement Policy to meet the changing needs of parents and the school.
- Dade Elementary School will adopt the school-parent compact as a component of its Parental Involvement Policy.

1.
