WHY THIS CONTRACT MATTERS

- Senior activities and graduation are privileges that come with responsibilities.
- The contract must be submitted by August 21, 2026 to be eligible to purchase or participate in senior activities.
- Senior expectations are in effect even if the contract has not yet been signed or returned.
- All seniors are expected to meet academic, attendance, behavior, and financial requirements throughout the year.

ACADEMIC EXPECTATIONS



Be Sure to.....

**STAY ON TRACK NOW -
DON'T WAIT UNTIL THE END
OF SENIOR YEAR.**



- Complete all academic requirements by May 7, 2027.
- Verify any additional APEX, Dual Enrollment, and/or college credits through Counseling by May 12, 2027.
- Earn a minimum of 220 credits and pass required classes.
- Classes must be passed by 3rd quarter to attend prom and grad bash.
- Submit FAFSA or an opt-out form AND complete at least one post-secondary application.

ATTENDANCE EXPECTATIONS

- Maintain at least 80% attendance each semester.
- Privileges may be lost if you exceed 18 period absences or 27 period tardies in a 2-week period.
- Truancy issues during the last semester must be cleared with an administrator to participate in senior events and/or graduation.
- Clear absences with official documentation or an administrator within 72 hours.
- Period absences and tardies cannot be made up and count toward your attendance total.



BEHAVIOR AND GRADUATION EXPECTATIONS



- Act in a mature and responsible manner at school and at all school-sponsored events.
- No in-school or out-of-school suspensions; suspension may affect participation in senior events, including graduation.
- Students with late start or early release may only be on campus during officially scheduled times.
- Graduation practice in late May 2027 is mandatory.
- If you have an unavoidable graduation-practice conflict, meet with an administrator the week before for approval.

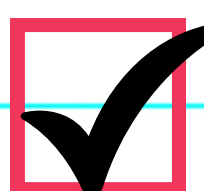
FINE, FEES AND NO GO STATUS



- By Senior Check-Out Day, pay all outstanding fines and fees.
- Return all school-issued uniforms, textbooks, and equipment.
- Your diploma will be withheld until items are returned and fees are paid in full.
- No refunds will be given for activities or events lost because eligibility requirements were not met.
- If you are on the 5Star no-go list, you cannot attend events or receive a refund.

WHAT DO I NEED TO DO?

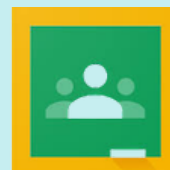
-  **Read the entire Senior Contract carefully.**
-  **Share the contract with your parent/guardian – this includes seniors who are 18 years old.**
-  **Complete all required information and obtain both student and parent/guardian signatures.**
-  **Return the completed contract by August 21, 2026 to Mr. Sam in the Athletics Office. It must be submitted to put your down payment on your senior package.**
-  **Remember: signing verifies that you were informed of the expectations; the standards apply to all AHS seniors.**
