



School Parent and Family Engagement Policy

A. ANNUAL TITLE I MEETING

Luis Muñoz Marín PK-8 School will take the following actions to conduct an annual meeting, at a convenient time, and encourage and invite all parents and family members of participating children to attend to inform them about the school's Title I program, the nature of the Title I program, the parents' and family members requirements, the school parent and family engagement policy, the schoolwide plan, and the school-parent and family compact.

B. FLEXIBLE NUMBER OF MEETINGS

Luis Muñoz Marín PK-8 School will offer a flexible number of engagement meetings in accordance with the OPHAS level as outlined in Part A at convenient times for parents and families, such as meetings in the morning or evening (for which the school may use Title I funds to provide transportation, childcare or home visits, as such services relate to parent and family engagement (if the state's current OPHAS Level is 1).

PAC Meetings will be held quarterly.

C. JOINTLY DEVELOPED

During monthly PAC Meetings, parents will be informed of school news, community happenings, and district initiatives. Parents are welcome to ask questions and provide input at these meetings or during any other point during the school year.

Luis Muñoz Marín PK-8 School will provide parents and families of participating children timely information about programs under Title I, including:

- a) a description and explanation of the curriculum in use,
- b) forms of academic assessment used to measure student progress,
- c) achievement levels of the challenging State academic standards, and
- d) if requested by parents and families, opportunities for regular meetings to formulate suggestions and participate, as appropriate, in decisions relating to the education of their children and respond to any such suggestions as soon as practicable possible.

Information related to the school and parent and family engagement programs, meetings, and other activities, will be provided to the parents and families of enrolled children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents and families can understand.

Monthly newsletters are distributed to all stakeholders. Parents are also engaged during PAC meetings as well as during different parent teacher conferences days. If ever a parent needs additional support, the school will provide that assistance.

E. DISSENSION PROCESS

Luis Muñoz Marín PK-8 School will submit any comments/concerns to the CMSD Office of Family and Community Engagement if the schoolwide plan and/or parent and family engagement policy is not satisfactory to parents and family members.
