6. **Ensure regular two-way, meaningful communication** with families, in a language parents can understand whenever practicable.

Additional Required Responsibilities:

- Involve parents in planning, reviewing, and improving the school's Parent and Family Engagement Policy and Schoolwide Program Plan.
- Hold an annual meeting to inform parents of Title I participation, requirements, and rights, with flexible scheduling.
- Provide information to parents in an understandable format, including alternative formats and languages as needed.
- Share explanations of the curriculum, assessments, and proficiency levels.
- Offer regular opportunities for parents to provide suggestions and participate in decisions about their child's education.
- Provide each parent with an individual student report of state assessment results.
- Notify parents if their child has been taught for four or more consecutive weeks by a teacher who does not meet state certification requirements.

Optional Responsibilities:

- Recommend interested parents for State or District advisory committees.
 - Work with the LEA to address issues implementing parent engagement activities.
 - Provide a copy of the SEA's written complaint procedures to parents and appropriate private school officials.
